ORDINANCE NUMBER 133

Controduced by W.A.Gregg.

An ordinance providing for the holding of a special election upon the question of whether or not the indebtedness of the City of Polson, Montana, shall be increased over and above the three per cent limit fixed by law, by the issuance of water bonds to the amount of Fifteen Thousand (\$15,000.00) Dollars to be used for the purpose of entarging, extending and constructing a water system for said city, which water system and extensions thereof, said city shall own and controll and devote the revenues derived therefrom to the payment of the debt incurred therefor.

BE IT ORDAINED BY THE CITY COUNDIL OF THE CITY OF POLSON:

Section 1 - That it is necessary and desirable and deemed for the best interests of the City of Polson, by the City Council, that said city enlarge, extend and construct a water system and that the city shall own and controll the same and devote the revenue derived therefrom to the payment of the indebtedness incurred therefore.

Section 2 - That a special election be held in the City of Polson, Montana, on the seventh day of April, 1919 for the purpose of accrtaining the will of the taxpayers to be affected thereby, and that authority may be given and power conferred upon the City Council of said city to increase the indebtedness of said city over and above the three per cent limity fixed by law by the issuance of water bonds of said city to the amount of Fifteen Thousand (\$15,000,00) Dollars for the purpose of enlarging. Thousand (\$15,000.00) Dollars for the purpose of enlarging, extending and constructing a water system for said city, which water system said city shall own and control and the revenues derived therefrom shall be devoted to the payment of the indebtedness incurred therefor.

Section3 - That the time and place of holding said election shall be as follows: At the City of Polson, State of Montana on the 7th day of April, 1919 from 8 o'clock A.M. to 6 o'clock P.M. of said day, and that the places of voting at said election shall be as follows:

7 ndst Ward - City Hall, 4th Street, Block 18.
/s X2nd Ward - Red Cross Building, 3rd Street, Block 11.
3rd Ward - Catholic Assembly Building, 4th Street, Block 29.

Section 4 - That the amount and character of the water bonds proposed to be issued shall be Fifteen Thousand (\$15,000.00) Dollars, that said bonds shall be fifteen (15) in number and their numbers from one to fifteen both inclusive, that said bonds shall be designated "Water Bonds", and shall be of the denomination of One Thousand (\$1,000.00) Dollars each, and the principal shall be payable in gold coin of the United States of America of the present standard weight and fineness, said bonds shall bear interest at the rate of six per cent per annum, payable semi-annually; shall be dated the 1st day of April, 1919, and shall be redeemable and payable as follows:

Five Thousand (\$5,000.00) Dollars of said bonds numbered from one to five both inclusive, shall be redeemable on and after the first day of April, 1923, and shall be paid on the first day of April, 1939; Five Thousand (\$5,000.00) Dollars of said bonds, numbered from six to ten, both inclusive, shall be redeemable on and after the first day of April, 1926, and shall be paid on the first day of April, 1929, and Five Thousand (\$5,000.00) Dollars of said bonds, numbered from eleven to fifteen, both inclusive, shall be redeemable on and after the first day of April, 1929, and shall be paid on the first day of April, 1939.

There shall be semi-annual interest coupons attached to said bonds, interest pauable semi-annually, in lawful money of the United States of America. The coupons and bonds shall be in such form as the Council by Ordinance Direct.

A tax to be fixed by ordinance must be levied each year for the purpose of paying interest on the bonds and to create a sinking fund for their redemption.

Whenever at any time after such bonds become redeemable, the sum in the sinking fund equals or exceeds One Thousand (\$1,000.00) Dollars, the City Treasurer mag redeem such amount of the bonds which may be payable or redeemable according to law.

Section 5 - That the ballot used at such election shall be of the ordinary white paper four inches by six inches in size, shall be printed in the following form; Proposition to increase the indebtedness of the City of Polson, Montana, over and above the three per cent limit fixed by law by the issuance of "Water Bonds" of said City to the amount of Fifteen Thousand (\$15,000.00) Dollars for the purpose of enlarging, extending and constructing a water system for said city, which shall own and controll said water system and devote the revenue derived therefrom to the payment of the debt incurred therefor.
