ORDINANCE NO 134

AN ORDINANCE DECLARING THE RESULT AND VALIDITY OF THE SPECIAL ELECTION HELD IN AND FOR THE CITY OF POLSON, OF THE COUNTY OF FLATHEAD, STATE OF MONTANA, ON MONDAY, TO-WIT: THE SEVENTH DAY OF APRIL A.D. 1919 BETWEEN THE HOURS OF EIGHT O'CLOCK A.M. AND SIX O'CLOCK P.M. PROVIDING FOR THE ISSUANCE, ADVERTISEMENT AND SALE OF FIFTEEN THOUSAND DOLLARS WATER BONDS OF, BY AND FOR THE SAID CITY AUTHORIZED BY THE DULY QUALIFIED ELECTORS THEREOF AT SAID ELECTION AND DECLARING AN EMERGENCY.

WHEREAS, In accordance with Ordinance No. 133 of the City of Polson, of the County of Flathead and State of Montana, passed and approved February 26th, 1919, a special bond election was called and predered to be held in and for said city on Monday, to-wit: the 7th day of April A.D. 1919, between the hours of eight o'clock A.M. and six o'clock P.M. for the purpose of voting upon the following question:

Shall the indebtedness of the city of Polson, Montana, be increased over and above the three per cent limit fixed by law, by the issuance of water bonds to the amount of fifteen thousand (\$15,000.00) dollars to be used for the purpose of emlarging, extending and constructing a water system for said city, which water system said city shall own and control and devote the revenue derived therefrom to the payment of the debt incurred therefor?

AND WHEREAS, The City Clerk has caused due and sufficient evidence of the lawful publication of said Ordinance, and notice of election appearing therein, and the proper posting of said notice, and the properposting and publishing of the notice of registration by the City Clerk, to be furnished to this council, and the said council has heretofore caused same to be filed of record as a part of the proceedings of this city, and

WHEREAS, After due canvass of the returns of said election as memade by the said city council acting as a board of canvassers, it was found, declared, certified and published that the total number of votes cast at sais election submitted thereat, was One hundred seven, of which ninety-three votes were "Bonds Yes" and fourteen votes were "Bonds No", and that there was a majority of seventy-nine of all the votes cast at said election "Bonds Yes"; said votes having been cast in the respective precincts of the city of Polson:

Now, therefore, in consideration of the premises,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF POLSON, as follows:

Section 1 - That the special bond election held in and for said city, on Monday, to-wit: the 7th day of April A.D. 1919, beginning at the hour of eight o'chock A.M. and closing at the hour of six o'chock P.M. be and the same is hereby determined and declared to have been duly called, noticed and held in strict compliance with law.

Section 2 - That the result of said election has been duly certified and returns thereof duly made to and convassed by said council and said canvass shows that the total number of votes cast at said election upon the following question:

Shall the indebtedness of the City of Polson, Montana, be increased over and above the three per cent limit fixed by law, by the issuance of water bonds to the amount of fifteen thousand (\$15,000.00) dollars to be used for the purpose of enlarging, extending and constructing a water system for said city, which water system said city shall own and control and devote the revenue derived therefrom to the payment of the debt incurred therefor?

was One hundred seven, of which ninety-three votes whre "Bonds Yes" and fourteen votes were "Bonds No", and that there was a majority of seventy-nine of all the votes cast at said election "Bonds Yes"; said votes having been cast in the respective wards of the City as follows:

Section 3 - That it be and is hereby certified, recited and warranted that at said election a majority of all of the duly qualified electors present and voting at said election voted in favor of the issuance of the bonds hereinabove mentioned; and that the council is hereby authorized and empowered to issue and sell the bonds of said city, of the character, to the amount and for the purpose aforesaid.

Section 4 - That the notice is hereby authorized, ordered and directed to be given and published as hereinafter provided that the council of said city will sell, at public auction, to the bidder offering the highest price therefor, said issue of bonds, as and in the manner provided by sections 3456 and 3457, revised codes of Montana of 1907, which said notice shall be in substantially the following form:

Pursuant to the authority of Ordinance No. 134 of the City of Polson, of the County of Flathead, State of Montana, passed and approved April 11th, A.D. 1919, authorizing and diricting the

preserve as a part of his files and records of his office and the other set of which he shall furnish to the purchaser of said bonds.

(c) The City Clerk be and he is nereby authorized, offered and directed to give the Board of Land Commissioners of the State of th Montana at least thirty days notice prior to the date of said sale a copy of said notice and advertisement thereof, also full and complete proof of the proceedings had with reference to the issuance of said bonds and proof of same as provided in Section 2199 of the Revised Codes of Montana of 19073

Section 5 - That on Monday, to-wit: the 26th day of May, A.D. 1919, at the hour of ten o'clock A.M. the said council will meet at the office of the City Clerk therein and shall consider the bids, if any, received for the bonds aforesaid and take such action thereon as the facts warrant and as by law authorized and provided.

Section 6 - That in as much as it is necessary for the immediate preservation of the public peace, health and safety that the city have a complete and adequate water system, an emergency is hereby declared to exist and this ordinance shall, therefore, be in effect from and after its passage and approval.
