

ORDINANCE NO. 135

AN ORDINANCE AMENDING SECTION 13 OF ORDINANCE NO. 128 OF THE CITY OF POLSON, ESTABLISHING A SYSTEM OF STREET GRADES, TO INCLUDE THE ESTABLISHMENT OF CERTAIN GRADES WITHIN THE CITY OF POLSON, MONTANA

WHEREAS, The City of Polson, by its City Commissioners, has caused levels to be taken and elevations determined, and a system of grades established upon the streets and avenues within said City and in order to clearly define and perpetuate the grades so established by this Ordinance:

BE IT ORDAINED BY THE CITY COMMISSIONERS OF THE CITY OF POLSON, MONTANA: -

That Section 13 of Ordinance No. 128 be amended, and is hereby amended, to include the grades of the streets and avenues at the points designated, and they are hereby established as the official grades of the said streets and avenues. Said points being the block corners respectively at streets and avenues herein named.

RESOLUTION NUMBER 26

A resolution providing for the creation of Special Improvement District Number 4 in the City of Polson, Montana, and stating the character of the improvements to be made and an approximate estimate of the cost thereof, in accordance with the Resolution of Intention heretofore adopted by the Council of said City.

- BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON? MONTANA:

Section 1 - That there is hereby created and established in the City of Polson, Montana, Special Improvement District No. 4 for the purpose of grading the streets and constructing side-walks, curbs and gutters along all that portion of the City of Polson, Montana, including all streets, alleys and intersections within the boundaries hereinafter particularly described.

Section 2 - The said Special Improvement District shall be known and designated as SPECIAL IMPROVEMENT DISTRICT-NUMBER FOUR of the CITY OF POLSON? MONTANA.

Section 3 - The boundaries of the said Special Improvement District Number Four of the City of Polson, Montana are hereby designated and described as follows, to-wit: -

Beginning at the point of intersection of the center line of the alley in block 20 and the line between lots 9 and 10 in block 20 of the Original Townsite of Polson; thence in a westerly direction on the line between lots 9 and 10 to the center of second street; thence west in the direction of a straight line forming the center of the alley in block 21 of the Original Townsite of Polson to the point of intersection with a line parallel to the west boundary line of First Street and Fifty feet west of the said west boundary line of First Street; thence north along the said parallel line for a distance of 173 feet; thence east to the west boundary line of First Street; thence northeasterly direction to the west corner post of lot 7 block 12 Original Townsite; thence in a northeasterly direction along the boundary line between Block 12 and the Public Park to the point of intersection with the line forming the center line of the alley in block 12 of the Original Townsite of Polson; thence east along the center line of the alley in block 12 to the center of Section Street; thence South along the center of Second Street to the point of intersection with the line forming the boundary between lots 7 and 8 in block 13 of the Original Townsite of Polson; thence east along the line which forms the boundary between lots 7 and 8 in block 13 to the point of intersection with the center of line of the alley in block 13; thence south along the center line of the alley in blocks 13 and 20 to the point of intersection with the line which forms the boundary between lots 9 and 10 of block 20, the same being the point of beginning.
