AN ORDINANCE REGULATING AND FIXING THE SALARIES OF CERTAIN OF THE OFFICERS OF THE CITY OF POLSON, MONTANA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA.

SECTION 1 - The compensation of the City Clerk, City Treasurer, City Attorney, Police Judge, Health Officer, Street Commissioner, Water Commissioner, Chief of Police, Policeman, Fire Chief, Assistant Fire Chief, Fireman, Librarian, Assistant Water Commissioner, Auditor of Improvement District Taxes, Truckman and Laborers is hereby fixed and established at the following named salaries; and that the same shall be accepted and taken as full compensation for all services to be rendered by said officers for the City of Polson:

City Clerk - - - - - - - \$100.00 per month
City Treasurer - - - - - 100.00 per year
City Attorney - - - - - 300.00 per year
Police Judge - - - - - 100.00 per year
Health Officer - - - - 100.00 per year
Street Commissioner - - 20.00 per month
Water Commissioner - - 20.00 per month
Chief of Police - - - 85.00 per month
Policeman - - - - 85.00 per month
Fire Chief - - - - 85.00 per month
Fire Chief - - - - 85.00 per month
Fire Chief - - - - 85.00 per month
Fire Thief - - - - - 85.00 per month
Tire Chief - - - - - 85.00 per month
Fire Chief - - - - - - 85.00 per month
Tire Chief - - - - - - - - - 85.00 per month
Fireman - - - - - - - - - - - - - - - 50¢ per hour
Truckman - - - - - - - - - - 50¢ per hour
Laborer - - - - - - - - 50¢ per hour
Auditor of Improvement Dist Taxes \$16.67 per month

SECTION 2 - The said several salaries shall be paid at the end of each month, by the order of the City Council and approval of the Mayor.

SECTION 3 - Whereas an emergency exists and it is necessary for the preservation of the peace, health and safety of the public, this ordinance shall take effect emmediately upon its passage and approval.
