

AN ORDINANCE CLOSING, VACATING AND DISCONTINUING CERTAIN PORTIONS OF THIRD STREET AND LAKE STREET IN THE ORIGINAL TOWNSITE OF THE CITY OF POLSON, LAKE COUNTY, MONTANA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. It is hereby declared, as a matter of legislative determination, that Sue E. Swanberg, Robert Swanberg and Lloyd Swanberg have filed with the City Clerk of the City of Polson a petition praying for the discontinuance of portions of Third Street and Lake Street, as hereinafter described, in Original Townsite of the City of Polson; that the said City Clerk has posted, in three public places in the City of Polson, a notice stating when and where said petition will be acted upon this by this Council and that said notice was so posted more than one week prior to this date; that said petitioners are the owners of all the lots abutting on the portions of said streets, as described in said petition sought to be discontinued; that no person or persons have appeared in opposition to said petition; that the portions of said streets, as described in said petition and as hereinafter set forth, may be discontinued without detriment to the public interest.

Section 2. That those parts or portions of Third and Lake Streets in the Original Townsite of the City of Polson, Lake County, Montana, described in as follows, to-wit:

"Beginning at the south east corner of Block Four of the original townsite of Polson, Montana; thence northeasterly 212 feet, more or less, to the south corner of the triangular Public Reserve; thence north along the west line of said Public Reserve; 117.2 feet, more or less, to the north west corner of said Public Reserve; thence southwesterly to the north corner of Block Four of original townsite of Polson, Montana; thence southwesterly along the meander line of the Flathead Lake to the point of intersection of said meander line of the north line of "B" street; thence east along the North line of "B" street 140.1 feet, original townsite of Polson, Montana, more or less to the south west corner of Block Four; thence northeasterly along the west line of said Block Four to the north corner of said Block Four; thence south along the east line of said Block Four to the place of beginning."

be, and the same are hereby, vacated and discontinued.

Section 3. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect thirty days after its final passage and approval.
