

AN ORDINANCE LICENSING AND REGULATING THE OPERATION OF BICYCLES ON STREETS, ALLEYS, AND HIGHWAYS, IN THE CITY OF POLSON, MONTANA, FIXING THE EFFECTIVE DATE OF THIS ORDINANCE, FIXING PENALTIES FOR VIOLATION, AND REPEALING ALL ORDINANCES IN CONFLICT.

Be it ordained by the City Council of the City of Polson, Montana:

Section 1. It shall be unlawful for any person to ride a bicycle on the streets, alleys, and highways within the City of Polson, Montana without the same first having been registered and licensed with and by the Police Department of the City of Polson, Montana, and without displaying the license plate, reflector and signal as herein-after provided for.

Section 2: Any person desiring to ride a bicycle on any street, alley and highway within the City of Polson, Montana, shall before riding the same on said street, alley, and highway in said city register the same with the Police Department of said city and shall have stamped thereon a registration serial number and shall procure therefor one (1) identification license plate and shall equip said bicycle with a red reflector in the rear, and a white light in front; the license plate to be displayed at the rear and kept so that is is easily discernible and the numbers thereon can be identified, the same as the license plates on automobiles.

Section 3. For the purpose of defraying the costs of the license plates and the registration of said bicycles the licensee shall pay to the city of Polson for each bicycle the sum of \$1.00, which shall be collected by the City Police and paid into a fund designated the Police Fund of the City of Polson, Montana.

Section 4. Any person violating the provisions of this ordinance, shall upon conviction, be fined the sum of not to exceed \$5.00, for each separate offense.

Section 5. All ordinances in conflict herewith are hereby repealed.

Section 6. This ordinance shall become effective 30 days after its passage and approval.

AN ORDINANCE FIXING LICENSES FOR SEPERATE SLOTS IN SLOT MACHINES, DECLARING AN EMERGENCY, AMENDING ANY PART OF ANY ORDINANCES IN CONFLICT, FIXING EFFECTIVE DATE, AND FIXING PENALTY.

Be it ordained by the City Council of the City of Polson, Montana:

Section 1. For each separate slot in any slot machine, operated, possessed or used in the City of Polson, a license fee of \$12.50 per year shall be paid to the City of Polson, Montana.

Section 2. All license fees therefor shall be due and owing not later than January 15th of each year, collectible by the City Treasurer of the City of Polson, Montana.

Section 3. Any person who fails to pay said license fee when due, or operates or uses the above-described machine without first procuring a license, or in any way violates this ordinance, shall be deemed guilty of a misdemeanor, and upon conviction shall be subject to a fine of not to exceed \$100.

Section 4. It is hereby declared that an emergency exists effecting the welfare of the inhabitants of the city of Polson, the police protection thereof, that this ordinance take effect immediately upon passage and approval, and by reason thereof this ordinance takes effect immediately upon its passage and approval.

Section 5. Any part of any ordinance in conflict is hereby amended to conform to this ordinance.
