AN ORDINANCE CHANGING NUMBER AND NAME OF STREET, REPEALING ORDINANCES IN CONFLICT.

Be it ordained by the City Council of the City of Polson, Montana;

- 1. That street, being a portion of first street East in the City of Polson, Montana, commencing at 7th Avenue and running south to the City limits, is hereby changed, so that the same shall be hereafter and now designated, named and called Skyline Boulevard.
- 2. All ordinances in conflict are hereby repealed.
- 3. This ordinance becomes effective 30 days after its passage and approval.

ORDINANCE NO. 242

AN ORDINANCE OF THE CITY OF POLSON MONTANA RELATING TO SEWERAGE CONNECTIONS WITH DRAINAGE LINE OF SYSTEM, FIXING PENALTIES, DECLARING AN EMERGENCY, FIXING EFFECTIVE DATE OF ORDINANCE, AND REPEALING ANY ORDINANCE IN CONFLICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION 1. No person, firm or corporation, or otherwise, may make sewerage connections, or otherwise, either with or without a septic tank, to the Polson City drainage line or system, by entering the line or manholes, or otherwise.

SECTION 2. No person, firm or corporation shall excavate, enter into, break, interfere with, or attempt to do so, for sewerage purposes, drainage, or otherwise, with or without a septic tank, of said drainage line or system.

SECTION 3. The provisions of this ordinance does not apply to the City or to a special improvement district, where adequate septic tank is provided as determined by both the City Council and the State Board of Health, provided permission to do so, or to use daid drainage line is first had and obtained by both and from both the City Council and the State Board of Health of the State of Montana.

SECTION 4. An emergency exists necessary to preserve the health and peace of the City of Polson, Montana and its inhabitants and by reason thereof an emergency is hereby declared, and this ordinance take effect upon its passage and approval.

SECTION 5. Any person, firm or corporation, or others, who violate this ordinance, upon conviction, shall be fined not to exceed \$300.00, or by imprisonment in the City jail for 90 days or by both such fine and imprisonment.

SECTION 6. A violation of this ordinance is hereby declared to constitute a nuisance and may be enjoined as provided for by law.
