

ORDINANCE NO. 246

AN ORDINANCE PROVIDING A METHOD FOR SPRINKLING THE STREETS EMBRACED WITHIN SPRINKLING DISTRICT NO. 14-M PAYING FOR THE SAME AND CREATING AN EMERGENCY THEREFOR.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA.

SECTION 1. That all of the streets included within oil District No. 14-M shall be sprinkled with oil during the summer season of 1954 by forces of the City of Polson.

SECTION 2. That the cost and expenses of sprinkling said streets with oil shall be assessed against all of the property exclusive of public parks and public places, embraced within such oil sprinkling district upon an area basis, and which cost shall be approximately \$3.00 per lot.

SECTION 3. WHEREAS: An emergency exists, and it is necessary for the preservation of the peace, health and safety of the public that this ordinance shall take effect immediately upon its passage and approval.

Passed by the City Council of said City of Polson and approved by the Mayor this 4th day of January 1954.

RESOLUTION NO. 135

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 14-M, DEFINING THE BOUNDARIES THEREOF AND ESTIMATE COSTS OF THE SAME.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA

SECTION 1. That an oil sprinkling district to be known and designated as Oil Sprinkling District No. 14-M is hereby created, at a cost of approximately \$3.00 per lot.

SECTION 2. That the boundaries of said oil sprinkling District shall be such as to include all of the area of the City of Polson, including the streets and avenues upon which the following described lots and blocks border:

Lots 2 to 6, inclusive, Block 3, Riverside Addition to the City of Polson.

Lots 7 to 11 inclusive in Block 1, Lots 9 to 16 inclusive in Block 2, all of Block 3, Lots 2 to 11 inclusive in Block 4, Lots 2 to 5 inclusive and 8 to 11 inclusive in Block 5, Lots 2 to 5 inclusive and lots 8 to 11 inclusive in Block 6, Lots 2 to 11 inclusive in Block 7, all of Blocks 8,9,10, Lots 2 to 11 inclusive in Block 11, Lots B and C in Block 12, all of Blocks 13,14,15 and 16, Lots 2 to 11 inclusive in Block 17, and all of Blocks 18,19,20, and 21 of Central Addition and Pend De'Oreille Heights Addition to the City of Polson.

Lots 7 to 12 inclusive in Block 1, Lots 7 to 12 inclusive in Block 2, Lots 7 to 12 inclusive in Block 3, Lots 5 to 8 inclusive in Block 4, and all of Blocks 5 to 16 inclusive in Lewis Addition to the City of Polson.

Lots 2 to 21 inclusive in Block 1, all of Blocks 2 and 3, Lots 1 to 10 inclusive and 26 to 38 inclusive in Block 4, Lots 13 to 24 inclusive in Block 5, all of Block 6, Lots 1 to 12 inclusive in Block 8, Lots 1 to 12 inclusive in Block 9, all of Lots in Blocks 10 and 11, Lots 13 to 24 inclusive in Block 12 of City Center Addition to the City of Polson.

Lots 13 to 24 in Block 2, Lots 13 to 24 inclusive in Block 3, all of Block 4 of Elevation Addition to the City of Polson. Y

Lots 1 to 4 inclusive in Block 2, Lots 5 to 8 inclusive in Block 1 of Pollmann Addition to the City of Polson.

All of Block 1, Lots 1 to 5 inclusive and 8 to 12 inclusive in Block 2, Lots 7 to 12 inclusive in Block 3, Lots 1 to 6 inclusive in Block 4, Arlisle Smith Property, Lots 1 to 5 inclusive and Lots 8 to 12 inclusive in Block 7, all of Block 8 of Polson Heights Addition to the City of Polson.

All of Block 1, Lots 1 to 5 inclusive and 8 to 12 inclusive in Block 2, Lots 2 to 6 inclusive and 7 to 11 inclusive in Block 3, Lots 1 to 5 inclusive and 8 to 12 inclusive in Block 4, Lots 1 to 6 inclusive in Block 5, Lots 2 to 6 and 7 to 11 inclusive in Block 6, Lots 1 to 5 inclusive and 8 to 12 inclusive in Block 7, all of Blocks 8 and 9, Lots 1 to 4 inclusive in Block 10, and Lots 7 and 8 in Block 10, Lots 2 to 6 inclusive and 7 to 11 inclusive in Block 11,
