

ORDINANCE NO. 253

AN ORDINANCE REPEALING ORDINANCE NO. 252, WHICH ABOLISHED THE OFFICE OF CITY ATTORNEY AND TRANSFERRED THE DUTIES TO THE MAYOR, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1. That Ordinance No. 252 of the City of Polson, Montana, passed and approved on May 2, 1955, be and the same hereby is repealed.

Section 2. An emergency is hereby declared making this ordinance effective immediately, by reason of the immediate necessity for the preservation of peace, health and safety of the City of Polson and its inhabitants.

Section 3. All ordinances in conflict herewith are hereby repealed.

RESOLUTION NO. 146

A RESOLUTION CREATING A SUB-DISTRICT WITHIN OIL SPRINKLING DISTRICT NO. 17, TO BE DESIGNATED AS SUB-DISTRICT NO. 140, DEFINING THE BOUNDARIES THEREOF, DESIGNATING THE IMPROVEMENTS TO BE MADE, AND THE ESTIMATED COST THEREOF.

IF IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. That a sub-district within Oil Sprinkling District No. 14, to be known and designated as Sub-district No. 14Q, is hereby created.

Section 2. That the boundaries of said Sub-district No. 14Q are hereby designated as the outside boundary lines of the hereinafter described lots and shall include all of the area of that portion of Oil Sprinkling District No. 14, including the streets upon which the following described lots and blocks abut:

Lots 5 to 8 inclusive in Block 7 and Lots 1 to 4 inclusive in Block 12 of Lakeshore Addition to the City of Polson.

Lots 1 to 6 inclusive in Block 3 of Riverside Addition to the City of Polson.

Lots 5 to 8 inclusive in Block 1 and all of Block 2 of Pollman Addition to the City of Polson.

All of Block 1, Lots 1 to 5 inclusive and Lots 8 to 12 inclusive in Block 2, Lots 7 to 12 inclusive in Block 3, all of Block 4, Lots 1 to 5 inclusive and Lots 8 to 12 inclusive in Block 7, and all of Block 8 of Polson Heights, an addition to the City of Polson.

All of Block 1, Lots 1 to 5 inclusive and Lots 8 to 12 inclusive of Block 2, Lots 2 to 6 inclusive and Lots 7 to 11 inclusive of Block 5, Lots 7 to 11 inclusive of Block 6, Lots 1 to 5 inclusive and Lots 8 to 12 inclusive of Block 7, all of Blocks 8 and 9, Lots 1 to 4 and Lots 7 and 8 of Block 10, Lots 2 to 11 inclusive of Block 11, all of Block
