AN ORDINANCE PROVIDING FOR A LEVY AGAINST THE TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, FOR THE PURPOSE OF COLLECTING A TAX FOR THE PAYMENT OF A JUDGMENT SECURED BY MAURICE F. KIELY AGAINST THE CITY OF POLSON, MONTANA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

That WHEREAS on March 22, 1941, Maurice F. Kely obtained a judgment in the District Court of the State of Montana, in and for Lake County, against the City of Polson, Montana, in the total amount of Two Thousand Three Hundred Eighty-Nine and 56/100 Dollars (\$2,389.56), upon which at the date hereof there is a balance unpaid in the amount of One Thousand Seven Hundred Fifty-five and 78/100 Dollars (\$1,755.78), together with interest theron, and

WHEREAS no provision has ever been made for the payment of said Judgment as required by Section 11-1501, Revised Codes of Montana, 1947,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Polson, Montana:

Section 1. That there is hereby levied on all of the taxable property within the City of Polson, Montana, a tax to establish a fund to be known as the "Kiely Judgment Fund", within a period of not more than three (3) years from and after the passage of this Ordinance.

Section 2. That the City Council of the City of Poslon, Montana, shall, at the proper times hereafter, when other taxes are levied, levy and cause to be collected with such other taxes sufficient taxes to retire said Judgment within the period of Three (3) years.

RESOLUTION NO. 148

A RESOLUTION OF INTENTION TO CREATE A SPECIAL IMPROVEMENT DISTRICT OF AND IN THE CITY OF POLSON, LAKE COUNTY, MONTANA, DESIGNATE THE NUMBER THEREOF, DERINING THE BOUNDARY OF THE SME, STATING THE GENERAL CHARACTER OF THE IMPROVEMENTS TO BE MADE, THE APPROXIMATE COST THEREOF, AND ORDERING AND DIRECTING NOTICE TO BE GIVEN UPON THE PASSAGE AND APPROVAL OF THIS RESOLUTION.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA

Section 1. That it is the intention of the City Council of the City of Polson, Lake County, Montana, to create a Special Improvement District, the boundary of which is hereinafter described.

Section 2. That said Special Improvement District shall be known and designated as SpecialnImprovement District Number 19 of the City of Polson, Lake County, Montana.

Section 3. That the boundaries of said Special Improvement District shall be the exterior boundaries of all of the lots abutting on all of that portion of Second Avenue East extending from the City limits on the West to the East end of Blocks Seven (7) and Eight (8), all in the Original Townsite of the City of Polson, Montana, and shall include the following lots:

Lot Three (3) of Block Four (4); Lots Six (6) and Seven (7) of Block Five (5); Lots Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), and Twelve (12), of Block Six (6);

Lots Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), and Twelve (12) of Block Seven (7)¢

Lots One (1), Two (2), Three (3), Four (4), Five (5), and Six (6) of Block Eight (8);
