Polson Flour Mill Block, Lots 1 to 6 inclusive in Block 1, Lots 1 to 8 inclusive in Block 2, Lots 1 and 12 in Block 5, Lots 1 and 12 in Block 6, and Lots 1 and 12 in Block 11 in Central Addition to the City of Polson.

Lots A, B, C in Block 12, Lots A, B, and 6 in Block 13, Lots A, B, and C and D, in Block 14, Lots 1 to 8 inclusive in Block 15, Lots 1 to 6 inclusive in Block 16, Lots 1 to 6 inclusive and Lot 12 in Block 17, and Hospital Block of Pend D'Oreille Heights Addition to the City of Polson.

Lots 1 to 6 inclusive in Block 1, Lots 1 to 6 inclusive in Block 2, Lots 1 to 6 inclusive in Block 3, and Lots 1 to 4 inclusive in Block & of Lewis Addition to the City of Polson.

Section 3. That the nature and character of the improvements to be made within said Sub-district 14T shall be the macadamizing, oiling and resurfacing of the streets therein, and all of said improvements shall be done by the forces of the City of Polson, Montana.

Section 4. That the estimated cost of making such inprovements is \$6,717.25 and shall be assessed against the lots therein on an area basis, at an approximate cost of \$8.00 per lot. All of said improvements shall be made in the year 1957, and all assessments made with the regular taxes for that year.

Section 5. That an emergency is hereby declared to exist, making it necessary for the preservation of the safety of the inhabitants of the City of Polson, Montana, that this resolution become effective immediately upon its passage and approval.

ORDINANCE NO. 255

AN ORDINANCE FIXING THE A MOUNT OF BONDS UPON QUALIFYING OF THE CITY TREASURER, CITY CLERK, CHIEF OF POLICE, AND OTHER CITY OFFICIALS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. That the City Treasurer, upon qualifying, must give an official bond or bonds in the amount of Three Thousand Dollars (3,000.00).

Section 2. That the City Clerk, upon qualifying, must give an official bond or bonds in the amount of Six thousand dollars (\$6,000.00)

Section 3. That the Chief of Police, upon qualifying, must give an official bond or bonds in the amount of One thousand dollars (\$1,000.00)

Section 4. That the City Council may require bonds of other city officials or employees when, in their judgment, such bonds are required and the amount of such bonds shall be fixed by the City Council.

Section 5. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
