ORDINANCE NO. 260

AN ORDINANCE DEFINING THE CRIME OF PETIT LARCENY, FIXING THE PENALTY FOR VIOLATION OF THIS ORDINANCE, AND AMENDING ORDINANCE NO. 191 BY ADDING THERETO A SECTION TO BE DESIGNATED SECTION NO. 692A.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA:

That Ordinance Number 191 be amended by adding thereto a new section designated as Section 692 A, to read as follows:

SUBSECTION 1. PETIT LARCENY DEFINED: petit larceny is hereby defined as follows: The ~~wrongful~~ taking and carrying away of any property of the value of less than Fifty Dollars (\$50.00), without valid claim of right, with the intention of converting it to a use other than that of the owner, without his consent.

SUBSECTION 2. PETIT LARCENY--PENALTY. Any person, committing the crime of petit larceny within the City of Polson, Montana, shall be guilty of a misdemeanor, and on conviction thereof, shall be punished by a fine not exceeding Three Hundred Dollars (\$300.00), or by imprisonment in the City Jail not exceeding One Hundred (100) days, or by both such fine and imprisonment.

SUBSECTION 3. WHEN TO TAKE EFFECT. This Ordinance shall be in full force and effect from and after its passage and approval, as provided by law and the ordinances of the City of Polson, Montana.

ORDINANCE NO. 261

AN ORDINANCE PROHIBITING POSSESSION OF BEER OR INTOXICATING LIQUOR BY PERSONS UNDER THE AGE OF TWENTY-ONE (21) YEARS AND DECLARING VIOLATION A MISDEMEANOR, FIXING THE PENALTY FOR VIOLATION THEREOF, DECLARING SAME TO BE AN EMERGENCY AND FIXING EFFECTIVE DATE, AND REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON:

SECTION 1. Any person who shall not have reached the age of twenty-one (21) years and who shall have in his or her possession, beer or intoxicating liquor shall be guilty of a misdemeanor.

SECTION 2. Any person who is convicted of a violation of this Ordinance will be punished by imprisonment in the City Jail for a period of not more than ninety (90) days, or a fine of not more than \$300.00, or by both such fine and imprisonment.

SECTION 3. This Ordinance is hereby declared to be an emergency ordinance, and passed in the interest of public health, welfare and safety, and shall be in full force and effect upon its passage and approval.

SECTION 4. All ordinances or parts of Ordinances in conflict herewith shall be and the same are hereby repealed.
