

ORDINANCE No. 264

AN ORDINANCE AMENDING SECTION 392 OF THE ORDINANCE NUMBER 191, THE REVISED ORDINANCES OF THE CITY OF POLSON BY ADDING THERETO A SECTION TO BE DESIGNATED AS SECTION 392A, PROVIDING FOR THE FIRE STOPPING OF UNOCCUPIED ATICS SPACES UNDER ROOFS OF COMBUSTIBLE CONSTRUCTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1: That Section ~~of~~ 392 of the Revised Ordinances of the City of Polson, Montana, No. 191 be and the same is hereby amended by adding thereto a section designated as 392A, reading as follows:

FIRE STOPPING CONCEALED PLACES

Unoccupied attic spaces under roofs of combustibile construction and above combustibile ceilings of occupied spaces shall be subdivided by partitions to form subdivisions nãt to exceed 3000 sq. ft area in each unless the attic is sprinklered in accordance with Section 46 of the National Fire Codes of 1959, Vol. III, or the ceiling construction beneath the attic has at least one-hour fire resistance as specified in Section 41 of the National Fire Codes of 1959, Vol. III. Required partitions dividing attic spaces shall be noncombustibile construction, or if combustibile, shall be designed to provide not less than one half hour fire resistance and any access openings therein shall be provided with closures at least equiblaent to the construction of the partitions. When wood is used for fire stops, a two-inch() nominal thickness is required and can be of double boards with lapped joints and must be good tight partitions extending from ceiling to roof.

Section 2: An emeggency is hereby declared to exist and this Ordinance is hereby declared to be necesssary of the immediate preservation of the public health and peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.
