ORDINANCE NO. 272
AN ORDINANCE FIXING THE SALARIES OF THE CITY CLERK AND WATER COLLECTOR, THE CHIEF OF POLICE, AND THE FIRE CHIEF, REPEALING SECTION 2, OF THE ORDINANCE NUMBER 267 AND ALL OTHER ORDINANCES, AND PARTS OF ORDINANCES IN CONFLICT HEREWITH: MAKING THE PROVISIONS OF THIS ORDINANCE EFFECTIVE AS OF JULY 1st,, 1961 AND DECLARING AN EMERGENCY.
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:
SECTION 1. That the salaries and wages of the following officers, appointe s, of the City of Polson, shall be fixed as hereinafter provided.
(a) City Clerk and Water Collector- The salary of the City Clerk and Water Collector shall be Three Hundred seventy five dollars (375.00) per month effective July 1st., 1961.
(b) Chief of Police- The salary of the Chief of Police shall be Four Hundred dollars (\$400.00) per month effective July 1st.;1961.
(c) Fire Chief- The Salary of the Fire Chief shall be continued at the present rate of Seventy Five dollars (\$75.00) per month.
SECTION 2. Repealing Clause-Section 2, of Ordinance No. 267, and all other Ordinances, and parts of Ordinances, in conflict herewith, are hereby repealed.
SECTION 3. Emergency Clause; An emergency is hereby declared to exist, and this Ordinance is necessary for the immediate preservation of the public peace, heal and safety; and therefore, this Ordinance shall be in full force and effect fro and after the date of its passage and approval.

ORDINANCE NO. 273

AN ORDINANCE CREATING THE OFFICE OF CITY DIRECTOR OF CIVIL DEFENS APPOINTING A DIRECTOR, AND DEFINING HIS DUTIES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, AS FOLLOWS:

SECTION 1. That this Ordinance be known as the Civil Defense Plan.

Section 2. That Ellen T. Wiedman, Director, Lake County, Montana, Civil Defense, be and she is hereby appointed City Director of Civil Befense to have direct responsibility for the organization, administration and operation of the City Organization for Civil Defense.

SECTION 3. That said director, or her successor in office, be and she or he is hereby empowered in case of natural disaster or subversive action or enemy action to use any City equpment of any kind or description and that she, or he may call upon any or all employees of the City of Polson to assist her or him, particularly those in charge of maint nance and operation of such equipment; and that no further authority shall be required for such ity Dir ctor of Civil Defense to act, and that this appointment be effective immediately from and after said director taking and filing the prescribed oath of office.

This Ordinance is passed as a police regulation for the protection of the public within the corporate limits of the City of Polson, and is hereby declared to be an mergency measure; and shall be in full force and effect, from and after its passage and approval.

ORDINANCE No. 274

AN ORDINANCE FIXING THE SALARIES OF THE CITY CLERK AND WETER COLLECTOR, THE CHIEF OF POLICE; THE FIRE CHIEF, POLICE PATROLIMAN, POLICE RELIEF PATROLMAN, MOTOR GRADER OPERATOR, AND PART_TIME LABORER; REPEALING SECTION 2 OF ORDINANCE NUMBER 267 AND ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH PROVIDING AN EFFECTIVE DATE, AND DECLARING AN EMERGENCY EXAME

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA: SECTION I. The salaries and wages of the following officers, and an employees of the City of Polson, Montana shall be fixed as hereinafter provided:

(a) City Clerk and water Collector: The salary of the City Clerk and Water Collectof shall be Three Hundred seventy-five dollars (\$375.000) per month effective uly 1st., 1961.

(b) Chief of Police: The salary of the Chief of Police shall be Four Hundred Dollars (\$400.00) per month effective Ju:y 1st. 1961.

(c) The salary of the Fire Chief shall be continued at the present rate of Seventy-five dollars (\$75.00) per month

(d) The salary of the police patrolman shall be three Hundred fifty Dollars (350.00) per month effective October 1st., 1961.

(e) The wage of the Police Relief Patrolman shall be \$12.00 per xxiiit

eight-hour shift effective July 1st., 1961

(f) The salary of the motor grader operator shall be three dollars (330.00) per month effective december 1, 1961.

(g) Part-time laborers shall be paid at the rate of one dollar and 75 cents per hour XXXXXX (\$1.75).
SECTION II REPEALING CLAUSE: Section 2, of Ordinance number 267, and all other ordinances and parts of ordinances in conflict herewith, are hereby repealed.

SECTION III. EMERGENCY CLAUSE: AN EMERGENCY is hereby declared to exist, and this Ordinances is necessary for the immediate preser vation of the public peace, health, and safety; and therefore, this rdinance shall be in full force and effect from and after the date of its passage and approval.
