

ORDINANCE No. 275

AN ORDINANCE PROVIDING FOR SICK LEAVE FOR EMPLOYEES OF THE CITY OF POLSON, MONTANA, AND PROVIDING FOR THE METHODS OF DETERMINING SUCH SICK LEAVE, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION I. Each employee of the City of Polson, Montana, who shall have been in continuous employment and service of such City, for a period of twelve months, x shall be entitled to, and shall be granted sick leave with pay, under the terms and conditions herein set forth, at the rate of one and one-quarter ~~days~~ (1 1/4) working days for each month of service.

SECTION III Such sick leave shall be granted only upon approval of the City Council, and if the City Council shall require, the employee shall furnish to the City Council; a Doctor's certificate, showing that the employee has been absent due to illness, except that no doctor's certificate shall be required ~~in cases of absence~~ in cases of ~~absence~~ absence because of illness which does not exceed thre (3) days.

SECTION II. Such sick leave may be accumulated to a total not to exceed thirty (30) ~~days~~ working days ~~per~~.

SECTION IV. An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of the public peace, health, and safety, and therefore this Ordinance shall be in full force and effect from and after the date of its passage and approval

ORDINANCE No. 276

AN ORDINANCE CREATING THE POLSON, MONTANA CITY PLANNING BOARD, FIXING THE NUMBER OF MEMBERS CONSTITUTING SUCH BOARD; THE METHOD OF APPOINTING SUCH MEMBERS, THEIR QUALIFICATIONS AND THE TERMS OF OFFICE, DEFINING THE POWERS OF SUCH BOARD, PROVIDING FOR THE SUBMISSION OF AN ANNUAL BUDGET TO THE CITY COUNCIL, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. Creation of The Board: There is hereby created a City Planning Board to be designated and known as the "Polson, Mntana City Planning Board.

Section 2. Board membership: Said Board shall consist of seven (7) member s, all of whom shall be qualified electors of Lake County, Montana, and shall b freeholders therin, and shall be appointed as follows;

- a. One (1) member shall be apointed by the City Council from its membership;
- b. One member to be appointed by the city council who may in the discr - tion of the city council be an employee or hold public office in the city or county in which the city is located;
- c. One (1) member to be appointed by the Mayor upon the designation of the county commissioners of the county in which the city is located.
- d. Four (4) citizen members to be appointed by the mayor, tow (2) of whom shall be resident free holders within the urban area, if any outside the city limits over which the planning Board has jurisdiction and two (2) of whom shall be resident freeholders within the City limits. Such citizen members shall hold no other office in the city government.

Section 3. Term of Office: Terms of the members who are officers of the city of Polson shall be coextensive with their respective terms of office to which they have been elected or appointed. The terms of office of the other members shall be four (4) years, except for the the trms of the first members appointed which may be fixed by agreem nt and rule of the board for anyn period of time from one year to four years in order to proved for x staggered terms with a minimum number to terms expiring in any singl year; provid d, however, any citiz n appointed may be removed from office by a majority vote of the City Council. Nothing contained h rein shall prevent the r appointment of a member whos term has expired.

Section 4. Vacancies: Vacancies occurring in citizens members of the Board at the end of the term shall be filled by the Mayor. Vacancies occurring on the board of official members, shall be filled by the City Council for the unexpired term. Absence from three (3) consecutive regular meetings of the Board shall constitute a resignation from the Board and upon request of the President such vacancy shall be immediately filled as above set forth.

Section 5. Qualifications of Citizen Members; The Citizen members shall be qualified by knowledge and experience in matters relating to the development of the City and County, and shall be resident freeholders in the area over which the Planning Board has jurisdiction, provided, however, that at least two (2) of such members shall be resident freeholders in the area outside the City limits over which the Planning Board has jurisdiction.

Section 6. Meetings: The Board shall fix the time for holding regular meetings but it shall meet at least once a month during each year.

Section 7. Officers: As soon as practicable after their appointment the Board shall meet and organize by electing a president and a vice-president.

Section 8. Budget: At the proper time as required by law the Board shall submit to the City a budget of its requirements for the fiscal year, which said budget shall be approved by the City Council.

Section 9. Expenses, Payments: All expenses of the Board shall be paid by the City upon claims presented to the City Council, in accordance with the list pertaining thereto.

Section 10. Powers: The Polson, Montana City Planning Board shall possess and have all powers and authority granted by the provisions of the laws of the State of Montana, and the ordinances of the City of Polson, Montana and shall perform all duties required thereunder.

Section 11. An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of the public peace, health, and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

Section 12. Repealing Clause: All Ordinances and parts of Ordinances in conflict herewith of the City of Polson, are hereby repealed.
