ORDINANCE NO. 280

AN ORDINANCE PROVIDING THAT NO CONNECTIONS MAY BE MADE TO ANY CITY SEWERS FOR THE USE OF PROPERTY LOCATED OUTSIDE OF THE CITY LIMITS, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION 1; From and after the passage of this Ordinance, no permits shall be granted, and no connections may be made to any sewer, either trunk sewer or lateral dewer, now installed or hereafter to be installed, for the purpose of serving any property lying outside of the City limits of the City of Polson, Montana.

SECTION 2: That an emergency is hereby declared to exist, making it necessary for the preservation of the health, safety and welfare of the inhabitants of the City of Polson, Montana, that this ORDINANCE become immediately effective upon its paggage and approval.

ORDINANCE NO. 281

AN ORDINANCE PROVIDING FOR REGULATIONS GOVERNING THE CONSTRUCTION, ALTERATION, REMOVAL, DEMOLITION, EQUIPMENT, USE AND OCCUPANCY, LOCATION AND MAINTENANCE OF BUILDINGS AND STRUCTURES?

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION 1: ADOPTION OF BUILDING CODE. There is herevy adopted by the City Council of the City of Polson, Montana, for the purpose of establishing rules and regulations for the construction, alteration, removal, demolition, equipment, use and occupancy, location and maintenance of buildings and structures, including permits and penalties, that certain building code known as the National Building Code, Abbreviated Edition, recommended by the National Board of Fire Underwriters, being particularly the 1955 edition thereof and the whole thereof, except insofar as the same may be in conflict with ordinances heretofore passed and approved, of which not less than three #3) copi s have been and now are filed in the office of the City Clerk of the City of Polson, Montana, and the same are hereby adopted and incorporated as fully as if set out at length herein, and from the date on which this ordinance shall take effect, the provisions thereof shall be controlling in the construction of all buildings and other structures within the corporate limits of the City of Polson, Montana.
