

ORDINANCE NO. 282

AN ORDINANCE AMENDING SECTION 153 OF THE REVISED ORDINANCES OF THE CITY OF POLSON, MONTANA, PROVIDING FOR THE PAYMENT OF WATER RENTAL, BY ADDING THERETO, A PROVISION FOR THE COLLECTION OF SEWER USE TAX AND THE MANNER OF BILLING SUCH CHARGES, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

(Section 1: That Section 153 of the Revised Ordinances of the City of Polson, Montana, be and the same is hereby amended to read as follows:

"SECTION 153: SAME - PAYMENT OF WATER RENTAL AND SEWER USE TAXES. All bills for water, whether by flat rate or meter, and sewer use taxes, are due and payable at the office of the water department the first day of each month for all water used the preceding month, and will become delinquent on the 10th day of the month, and if still delinquent on the 15th day of the month, the water will be shut off, and shall not be turned on until all bills are paid, including an additional charge of one dollar (\$1.00) for turning on. Owners of property served will be held liable for all water and service charges. Payments will be accepted from tenants, but that will not relieve the owner if tenant becomes delinquent. Statements will be rendered to the owner, unless the owner or a qualified agent or representative shall, in writing, authorize bills to be to the tenant; but, such authorization shall not relieve the owner from payment of such charges, if the same are not made as hereinbefore provided."

Section 2: An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health, and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval

ORDINANCE NO. 283

AN ORDINANCE AMENDING ORDINANCE NO. 235, ENTITLED "AN ORDINANCE CREATING AND ESTABLISHING 'SPECIAL IMPROVEMENT DISTRICT REVOLVING FUND' IN AND FOR THE CITY OF POLSON, LAKE COUNTY, MONTANA, DECLARING AN EMERGENCY, FIXING THE EFFECTIVE DATE OF THIS ORDINANCE, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH."

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA: Ordinance No. 235 be, and the same is hereby amended to read as follows;

SECTION 1. There is hereby established and created a "Special Improvement District Revolving Fund", within and for the City of Polson, Montana, in order to secure prompt payment of special improvement district bonds and warrants issued in payment of improvements made, or to be made

in any district or districts heretofore created or hereafter created, which said revolving fund shall, at the discretion of the City Council, be maintained by a levy upon all of the taxable property within the said City of Polson, Montana, in such amount and to such extent as is required, and for such time as may be required in order that said bonds, together with interest, shall be fully paid in accordance with the terms, conditions, tenor and affect thereof.

SECTION 2. That for the purpose of maintaining and providing funds for such revolving fund the City Council of the City of Polson, Montana.

1. May in its discretion, from time to time, transfer to the revolving fund from the general fund of the City such amount or amounts as may be deemed necessary, which amount or amounts so transferred shall be deemed and considered, and shall be, loans from such general fund to the revolving fund; and;

2. Shall, in addition to such transfer or transfers from the general fund, or in lieu thereof, levy and collect for such revolving fund such a tax, hereby declared to be for a public purpose, on all the taxable property in the City of Polson, Montana, as shall be necessary to meet the financial requirements of such a fund, such levy, together with such transfer, not to exceed in any one year, five per cent (5%) of the principal amount of the outstanding special improvements district bonds and warrants.

SECTION 3. That all funds now in said "Special Improvement Revolving Fund", and all funds hereafter placed therein, shall constitute said fund.

SECTION 4. That there is hereby declared an emergency existing and this ordinance is immediately necessary for the preservation of the peace, health, and safety of the City of Polson, Montana, and the inhabitants therein, and by reason thereof shall become effective immediately upon its passage and approval.

SECTION 5. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
