AN ORDINANCE TO REGULATE THE KEEPING AND PASTURING OF HORSES.
MULES. OR COLTS IN THE CITY OF POLSON. MONTANA: PROVIDING FOR
PERMITS FOR KEEPING AND PASTURING HORSES. MULES OR COLTS IN THE
CITY OF POLSON. MONTANA; AND FIXING LICENSE FEES THEREFOR;
PROHIBITING THE KEEPING OF GOATS. HOGS. CATTLE. CHICKENS. TURKEYS.
DUCKS. GEESE AND OTHER DOMESTIC ANIMALS AND FOWL EXCEPTING HOUSE
HOLD PETS WITHIN THE CITY OF POLSON. MONTANA: DEFINING OFFENSES
AGAINST THIS ORDINANCE AND PROVIDING PENALTIES FOR SUCH VIOLATIONS:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON.

MONTANA:

Section 6-2-7: The riding. leading. herding or running at large of horses. mules. or colts upon the City streets. avenu s. alleys. parks or public places or grounds within the City is hereby prhibited and declared to be a nuisance except that horses. mules. or colts may be led or ridden by person capable of handling such animal from pasture within the City of Polson over public streets on alleys to the City is not a such animal from pasture within the City of Polson over public streets or alleys to the City Limits. and in organized parades.

Section 6-2-8: It is hereby made and declared unlawful and a nuisance for any hogs. cattle. sheep. swine. goats. chickens. turkeys. ducks. geese or other domestic animals or fowl excepting household pets to be kept within the corporate limits of the City of Polson and any such animals or fowl so kept within the City ar

hereby declared to be a nuisance and violative of this ordinanc and the continuance of the same shall be regarded as a sep rat offense to be punished as such seperate offense.

Section 6-2-9:

It shall be unlawful for any person to keep or pasture any horses. mules or colts within the City Limits without first obtaining an annual permit from the City Council. Upon application to the City Council and presentation of evidence showing ability to comply with the provisions of this Ordinance and Council approval of such application. The City Clerk of the City of Polson must issue such permit. Such application must be made on or before July 25. 1965. for horses. mules or colts currently pastured within the City. and. any person. desiring to pasture horses. mules or colts after the 25th. day of July. 1965. must apply for and obtain a permit prior to pasturing such animals.

Permits must be renewed annually on or before July 1. of ach y ar

No renewal permit issued unless owner strictly complies with provisions

of this ordinance.

Section 6-2-10: Fees: and Permits; Before any permit shabe issued by the City Clerk such owner of horses, mules or colts Before any permit shall wishing to pasture the same within the City of Polson. Montana shall pay a permit fee of TwO (\$2.00) Dollars per animal p r y ar. Section 6-2-11: Fencing and Area Regulation; It shall be

unlawful for any person to keep or maintain any horses. mules or colts within a radius of fifty (50') Feet of any dwelling or business house other than that occupied by the person owning said horses. mules or colts. and it shall be unlawful for any person to keep or maintain any stable. barn or feeding area for any horses. mules or colts within a radius of one hundred (100') feet of any dwelling or business other than that occupied by the person owning such horses. mules or colts and desiring to maintain a stable. barn or lot area.

The area provided for in this Section and maintained by the

The area provided for in this Section and maintained by the owner of any horses. mules or colts for pasture or stabling purposes within the City must confined by a legal fence as defin d by the revised Codes of Montana. 1947. Section 46--1401. compl tely encircling the desired pasture or stable area. The provision of this section must be complied with by July 25. 1965

Section 6-2-12: Offensive Premises for Keeping Animals:
Anyone who shall within the Limits of the City of Polson. Montana. keep or maintain any pen. enclosure. stable or building for hors s mules or colts in such a filthy or unsanitary condition so as to be offensive to neighbors or other persons or injurious to the h alth of the neighborhood shall be guilty of maintaining a nuisance and violative of this Ordinance. and the continuance of the same shall be r garded as a leperate offense to be punished as such sep rate offense. offense.

Section 6-2-13: Penalty: Any person convicted of violating any provision of this ordinance shall have their p rmit revoked and shall in addition to and not in li u of such r vokation shall be fined not 1 ss than Ten (\$10.00) nor more than one Hundred (\$100.00) dollars for each offense.

Section 6-2-14: All Fees; fines. and forfeitures collected hereund r shall be depodited in the g neral fund of the City of Polson. and dispensed as the City Council may provide.

Section 6-2-15: S ctions 6-2-1. 6-2-2. 6-2-3. 6-2-4. 6-2-5. and 6-2-6 of the Revised Cod s of Polson 1965. Ordinanc No. 190
