

RESOLUTION NO. 222.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA VACATING AND ABANDONING THE SOUTHWEST 25 FEET OF KOOTENAI AVENUE: beginning at the corner of second street east, thence running south ~~west~~ easterly for the entire length of Block one, Original Townsite, Polson Montana, a distance of approximately 426.62 Feet.

WHEREAS, the City of Polson, Montana, is the owner of the SW 25 feet of Kootenai Ave. beginning at the corner of Second St. East thence running Southeasterly for the entire length of Block One (1), Original Townsite, Polson, Montana, a distance of approximately 426.62 feet.

Whereas: on the 18th day of October, 1965, a petition was filed signed by One Hundred Percent (100%) of all owners of lots on the part of Kootenai Avenue described herein, and

WHEREAS: on the 19th day of October, 1965, the city Council did pass and authorize the City Clerk to give notice of a public hearing to be held on said petition and directing the City Clerk to post notice of said hearing in three public places and publish said notices twice in the Flathead courier, a weekly ~~paper~~ newspaper, stating that determination of abandonment of said Avenue will be held on the 1st day of November, 1965, at the city hall, City of Polson, Montana, when and where any persons interested may appear and be heard for or against the abandonment of said Avenue, and

WHEREAS: the City Clerk did give notice of said hearing as required by law by causing the same to be published in the Flathead Courier on October 21st, 1965 and October 28th, 1965, and by posting the same in three public places, and

WHEREAS: a public hearing for final determination of the abandonment of the said public thoroughfare was held at the city hall of the City of Polson, Montana, on November 1, 1965, as hereinbefore provided, at which hearing all interested persons were given full opportunity to be heard for or against the abandonment of said public thoroughfare, and

WHEREAS: after full hearing and due consideration, it appears to ~~the~~ the Mayor and Council of the said City of Polson, Montana, that it is to ~~the~~ the best interest of said City of Polson, and the people thereof that said public thoroughfare be vacated.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that the Southwest 25 feet of Kootenai Avenue Beginning at the corner of Second Street East, thence Southeasterly for the entire length of Block One (1), Original Townsite, Polson, Montana, a distance of approximately 426.62 feet will be and hereby is vacated and abandoned.

ORDINANCE NO. 295.

AN ORDINANCE PROHIBITING THE OWNER OR OPERATOR OF A MOTOR SCOOTER, MOTOR CYCLE OR MOTOR BIKE FROM OPERATING THE SAME UPON THE CITY STREETS OF POLSON, MONTANA, WITHOUT WEARING A STANDARD MOTOR CYCLE HELMET AND PROVIDING HELMETS FOR ANY PASSENGERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA: That Section 10-2-17 be added to Ordinance 290, Revised Codes, City of Polson, 1965, to read as follows:

10-2-17; MOTOR CYCLE HELMETS: It shall be unlawful and constitute a misdemeanor for any owner or operator of a motor bike, motor scooter, or motor cycle to operate or allow said motor bike, motor scooter, or motor cycle to be operated or carry any passenger or passengers unless said operator and passenger or passengers are wearing standard motorcycle helmets.
