ORDINANCE NO. 307.

AN ORDINANCE AMENDING CHAPTER 7 OF CITY CODE OF POLSON, L965, BY THE ADDITION OF SUBSECTION 5-7-20, WHICH SECTION MAKES IT ILLEGAL FOR A MINOR UNDER THE AGE OF TWENTY-ONE (21) YEARS TO HAVE IN HIS POSSESSION BEER, WINE, OR OTHER INTOXICATING LIQUOR, AND DECLARING IT AN EMERGENCY MEASURE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 7 of the City Code of Polson, 1965, shall be, and the same hereby is, amended by the addition of Section 5-7-20 which shall be as follows:

POSSESSION OF BEER OR LIQUOR BY MINOR - MISDEMEABOR.
ANY PERSON WHO SHALL NOT HAVE REACHED THE AGE OF TWENTY-ONE
(21) YEARS AND WHO SHALL HAVE IN HIS OR HER POSSESSION BEER
OR LIQUOR, SHALL BE GUILTY OF A MISDEMEANOR.

REPEALING CLAUSE. All Ordinances and parts of Ordinances in

conflict herewith are hereby repealed.

EMERGENCY, An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

ORDINANCE NO. 308.

AN ORDINANCE AMENDING SECTION 5-7-19 OF CITY CODE OF POLSON, L\$65, MAKING IT ILLEGAL TO SELL, GIVE, OR OTHERWISE FURNISH ANY BEER OR ANY INTOXICATING LIQUOR TO ANY MINOR UNDER THE AGE OF TWENTY-ONE (21) YEARS, TO ANY INTOXICATED, INSANE, IDIOTIC PERSON, TO AN HABITUAL DRUNKARD, OR TO SELL ANY BEER OR INTOXICATING LIQUOR IN ANY MANNER NOT IN COMPLIANCE WITH THE LAWS OF THE STATE OF MONTANA OR THIS CITY. AND DECLARING IT AN EMERGENCY MEASURE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON,

MONTANA:

Section 5-7-19 of City Code of Polson, 1965, shall be amended to reas as follows:

RESTRICTIONS AS TO MINORS AND OTHER SPECIFIED PERSONS: IT SHALL BE UNLAWFUL FOR ANY PERSON, FIRM, PARTNERSHIP, OR CORPORATION TO SELL, GIVE FURNISH, OR OTHERWISE SUPPLY ANY BEER, WINE, OR ANY INTOXICATING LIQUOR TO ANY MINOR UNDER THE AGE OF TWENTY-ONE (21) years. to an inTOXICATED, INSANEM IDIOTIC PERSON, TO AN HABITUAL DRUNKARD, OR SELL ANY BEER OR INTOXICATING LIQUOR IN ANY MANNER NOT IN COMPLIANCE WITH THE LAWS OF THE STATE OF MONTANA OR THIS CITY. MONTANA OR THIS CITY.

REPEALING CLAUSE, All Ordinances and parts of Ordinances in KMM conflict herewith are hereby repealed.

EMERGENCY. An Emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.
