## ORDINANCE NO. 309.

AN ORDINANCE AMENDING SECTION 5-7-9- OF THE CITY CODE OF POLSON, 1965, SO THAT PERSONS UNDER THE AGE OF TWENTY-ONE YEARS MAY UTILIZE THE DINING FACILITIES IN ESTABLISHMENTS WHERE ALCOHOLIC BEVERAGES ARE SOLD AT RETAIL.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 5-7-9- of the City Codes of Polson, 1865, shall be amended to read as follows:

PROHIBITED PREMISES; TO WHOM: No licensee, or his or her employee, shall allow or permit any person under the age of twenty-one (21) years, or any intoxicated or disorderly person to congregate, be or remain in or about his premises, or be employed therein, provided. however, that the prohibition xxxxx relative to persons under the age of twenty-one (21) shall not be applicable to those retail liquor establishments located within the City Limits of the City of Polson, Montana, which operate dining room facilities.

REPEALING CLAUSE. All ordinances and parts of ordinances in

conflict herewith are hereby repealed.

EMERGENCY. An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

## ORDINANCE NO. 310.

AN ORDINANCE AMENDING SECTION 5-7-6 OF ORDINANCE NO. 290 REVISED CODES, 1965, BY ADDING A PROVISION SPECIFYING THE FEES REQUIRED TO BE PAID PRIOR TO THE TRANSFER OF A LICENSE ISSUED PURSUANT TO THE TERMS OF CHAPTER 5 OF THE CITY CODE OF POLSON, 1965.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON,

Section 5-7-6 of the City Codes of Polson, 1965, shall be amended to read as follows:

Transfers: Every license issued under this chapter shall set forth the name of the person to whom issued and the location by street number of the premises where the business is to be carried on under said license. If it is a partnership it shall set forth the names of the persons conducting the business. Such license shall be signed by the \*\*tirensee\*, and shall be non-transferable; provided, however, that a transfer of any such license may be made by application to the city council, accompanied by a transfer fee in the amount of ten per cent (10%) of the fee initially charged for the issuance of the license to the transferor as set forth in Section 5-6-6- of this Code, and provided further that such application must be accompanied by satisfactory \*\*ridensee\* of the consent of the Montana Liquor Control Board of such transfer of the license issued by it under the laws of the State of Montana. Such license shall be posted in a conspicuous place on the premises in respect to which it is issued and shall be exhibited to any member of the Police Department of the City whenever the same is \*\*required.\*\* Every license issued under the provisions of this Chapter is separate and distinct, and no person, except the licensee therein named, shall exercise any of the privileges granted thereunder, and all licenses are applicable only to the premises in respect to ehich they are issued; provided however, that a change of premises of any license may be made on application to the Council, accompanied by satisfactory evidence of the consent of the Montana Liquor Control Board. to such change of place of premises of the license by it issued under said act. all licenses shall expire at midnight on June 30 of each year.

REPEALING CLAUSE. All ordinances and parts of Ordinances

in conflict herewith are hereby repealed.

EMERGENCY. An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.

## ORDINANCE NO. 311.

AN ORDINANCE AMENDING SECTION 5-6-6 OF ORDINANCE NO. 290 REVISED CODES, 1965. BY ADDING A PROVISION SPECIFYING THE FEES REQUIRED TO BE PAID TO THE CITY OF POLSON UPON THE TRANSFER OF ALL LICENSES SET FORTH IN SAID SECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION 5-6-6- of Ordinance No. 290 of the Revised Codes of Polson, 1965, shall be amended to read as follows:

REQUIREMENTS: LICENSE FEES: A person who desires to engage in the business of manufacturing, selling or destribution of beer in the said City under the provisions of State Law in the character of places hereinafter mentioned, shall, notwithstanding the fact that the person conducting such place has obtained a license from the Montana Liquor Control Board, first apply for and obtain a license therefor from said City, as herein provided, and if such license is granted, shall pay therefor an annual license fee as follows:

Retailer - Bars Retailer - Grocery Stores Fraternal Organizations Any unit of a nationally Chartered Veterans Organization

\$300.00 \$200.00 \$100.00

\$100.00

If any license issued by a the Montana Liquor Control Board, under the provision of the "Montana Beer Act" shall be revoked or shall be suspended, the Accompanying license issued under this Chapter shall be automatically revoked and suspended for the same period, and in such event, the action of the Montana Liquor Control Board shall, upon appeal be modified or set aside the suspension or revocation of the license issued hereunder shall likewise be automatically affected. All licenses issued hereunder shall expire at midnight on June 30th each year. No license provided for by this section shall be transferred by the City Clerk of the City of Polson, Montana, unless the transferee shall have first made application to the City Council, which application must be accompanied by transfer fee in the amount of ten per cent (10%) of the initial license fee, as hereinabove set forth, togather with satisfactory evidence that the transfer has been approved by the Montana Liquor Control Board.

REPEALING CLAUSE. All ordinances and parts of ordinances
