ORDINANCE NO. 316.

AN ORDINANCE AMENDING CHAPTER 2 OF TITLE 6 OF THE CITY CODE OF OF POLSON, 1965, BY ADDITION OF SECTION 6-2-15 MAKING THE PICKETING OF ANY HORSE, MULE OR COLT WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, UNLAWFUL, AND DECLARING IT AN EMERGENCY MEASURE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON,

MONTANA:

Chapter 2 of Title 6 of the City Code of Polson, 1965. shall we amended by the addition of Section 6-2-15 which shall read as follows:

PICKETING UNLAWFUL: IT SHALL BE UNLAWFUL FOR ANY PERSON, FIRM, OR CORPORATION TO KEEP OR MAINTAIN ANY HORSE, MULE OR COLT WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, IN ANY MANNER OTHER THAN IN A LEGAL ENCLOSURE AS DEFINED BY SECTION 6-2-110F THIS CODE AND IT IS HEREBY MADE SPECIFICALLY UNLAWFUL AND A VIOLATION OF THIS ORDINANCE FOR ANY PERSON, FIRM OR CORPORATION TO PICKET OR TETHER ANY HORSE, MULE OR COLT FOR GRAZING PURPOSES OR OTHERWISE WITHIN THE CITY LIMITS OF THE CITY OF POLSON MONTANA. LIMITS OF THE CITY OF POLSON, MONTANA:
REPEALING CLAUSE: All Ordinances and parts of Ordinances

in conflict herewith are hereby repealed.

EMERGENCY. An Emergency is hereby declared to exist and this Ordinance is hereby declared to br necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approva.l PASSED AND APPROVED this 4th day of March, 1968.

ORDINANCE NO. 317.

AN ORDINANCE AMENDING PARAGRAPH 2 OF SECTION 6-2-11 OF THE CITY CODE OF POLSON, 1965, TO PROVIDE THAT A TWO-POLE FENCE SHALL BE A LEGAL FENCE FOR THE PURPOSE OF SAID ORDINANCE, AND DECLARING IT AN EMERGENCY MEASURE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON,

MONTANA:

Paragraph 2 of Section 6-2-11 of the City Code of Polson, 1965,

shall be amended to read as follows:
THE AREA PROVIDED FOR IN THIS SECTION AND MAINTAINED BY THE THE AREA PROVIDED FOR IN THIS SECTION AND MAINTAINED BY THE OWNER OF ANY HORSE, MULES, OR COLTS FOR PASTURE OR STABLING PURPOSES WITHIN THE CITY OF POLSON MUST BE COMPLETELY ENCLOSED BY A LEGAL FENCE AS DEFINED BY THE REVISED CODES OF MONTANA 1947, Section 46-1401. IN ADDITION TO THE FENCES SPECIFICALLY DESCRIBED IN SAID SECTION, A TWO POLE FENCE CONSTRUCTED IN SUCH AXMA MANNER THAT IT WILL CONTAIN HORSES, MULES, AND COLTS, SHALL BE CONSIDERED A LEGAL FENCE FOR THE PURPOSE OF THIS ORDINANCE. IT SHALL BE UNLAWFUL FOR ANY PERSON, FIRM OR CORPORATIONTO KEEP ANY HORSE, MULE OR COLT WITHIN THE CITY LIMITS OF THE CITY OF POLSON, THAT CSNNOT BE CONFINED IN AN ENCLOSURE MEETING THE REQUIREMENTS OF A LEGAL FENCE AS SET FORTH IN THIS SECTION.
