

ORDINANCE NO. 325

AN ORDINANCE AMENDING CHAPTER TWO OF TITLE TEN OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION ELEVEN THEREOF BY THE ADDITION OF SUB-SECTION (1) CREATING A TURNING LANE ON THE EAST SIDE OF MAIN STREET AT ITS INTERSECTION WITH U. S. HIGHWAY 93.

WHEREAS, in the opinion of the City Council of the City of Polson, Montana, a traffic hazard exists at the intersection of Main Street with U. S. Highway 93 by reason of there being no turning lane on the east side of Main Street as it intersects U. S. Highway 93, and:

WHEREAS, it is deemed to be in the best interests of the citizens of the City of Polson, Montana, and visitors thereto, that seventy-five foot (75 foot) turning lane be created on the east side of Main Street at its intersection with U. S. Highway 93,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter Two of Title Ten of the City Code of Polson, 1965, shall be amended by adding a sub-section (I) to section eleven thereof which shall read as follows:

10-2-11 (I): TURNING LANE: A turning lane is hereby created on the east side of Main Street at its intersection with U. S. Highway No. 93. Said turning lane shall be seventy-five (75) feet in length measured from the intersection of Main Street and U. S. Highway No. 93, at the curb line, in a southerly direction. All parking in said seventy-five (75) foot area shall be, and the same is hereby declared eliminated and from and after the effective date of this Ordinance it shall be illegal for any person, firm, or corporation to utilize said space for parking, except in the case of an emergency and for the purpose of loading and unloading bus passengers and freight, and provided further that said temporary bus parking shall be parallel with the curb line.

BE IT FURTHER ORDAINED by the City Council of the City of Polson, Montana, that the Street Department shall clearly mark said turning lane by painting appropriate lines on Main Street and the curb at the easterly side of said turning lane and further shall provide and erect appropriate signs on the said curb.

BE IT FURTHER ORDAINED by the City Council of the City of Polson, Montana, that the Police Department shall, from and after the effective date of this Ordinance and the completion of the painting of the appropriate lines and the erection of appropriate signs, strictly enforce the terms of the foregoing Ordinance.

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

ORDINANCE NO. 32⁶~~7~~

AN ORDINANCE AMENDING CHAPTER 3 OF TITLE 6 OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION 6-3-13 THEREOF PROHIBITING DOGS FROM RUNNING AT LARGE WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, FROM THE 5th DAY OF MARCH, 1970, THROUGH THE 5th DAY OF SEPTEMBER, 1970, AND FOR A LIKE PERIOD OF TIME EACH AND EVERY YEAR THEREAFTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 3 of Title 6 of the City Code of Polson, 1965, shall be amended by amending Section 6-3-13 thereof, to read as follows:

6-3-13: LEASH REQUIREMENT: No dog shall be permitted to run at large within the City Limits of the City of Polson, Montana, from the 5th day of March, 1970, to the 5th day of September, 1970, and for a like period of time during the calendar year, 1971, and for a like period of time during each and every year thereafter.

REPEALING CLAUSE: All Ordinances of parts of ordinances in conflict herewith are hereby repealed.

EMERGENCY: A public emergency is not deemed to exist at this time and therefore this Ordinance shall not be effective for thirty (30) days from and after the date hereinafter set forth.
