Polson, Montana, shall be extended so as to include the hereinbefore described contiguous tracts of land within the corporate limits thereof;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that it is their intention to extend the boundaries of the City of Polson, Lake County, Montana, so as to include the above-cescribed contiguous tracts of land within the corporate limits thereof, and;

BE IT FURTHER RESOLVED that in the judgment of the City Council of the City of Polson, Lake County, Montana, it will be to the best interests of the City and the inhabitants thereof, and in the best interests of the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the Gity of Polson, Montana.

BE IT FURTHER RESOLVED that the City Clerk of the City of Polson, Montana, forthwith notify in writing all property holders within the boundaried of the hereinbefore described tracts of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson once a week for two (2) successive weeks, a notice of the passage of this Resolution, which notice shall further state that for a period of twenty (20) days after publication thereof, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the City of Polson, Montana, as in this Resolution Provided, from free holders of the territories herein proposed to be embraced in the corporate limits of the City of Polson, Montana.

The foregoing Resolution was duly and regularly passed by the City Council of the City of Polson, Montana, and adopted and approved by the Mayor of the City of Polson, Montana, this 18gh day of May, 1970.

ORDINANCE NO. 327

AN ORDINANCE AMENDING CHAPTER 3 OF TITLE 6 OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION 6-3-13 THEREOF PROHIBITING DOGS FROM RUNNING AT LARGE WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, FROM THE 5th DAY OF MARCH, 1970, THROUGH THE 5th DAY OF SEPTEMBER, 1970, AND FOR A LIKE PERIOD OF TIME EACH AND EVERY YEAR THEREAFTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 3 of Title 6 of the City Code of Polson, 1965, shall be amended by amending Section 6-3-13 thereof, to read as follows:

6-3-13: LEASH REQUIREMENT: 'No dog shall be permitted to run at large within the City Limits of the City of Polson, Montana, from the 5th day of March, 1970, to the 5th day of September, 1970, and for a like period of time during the calendar year, 1971, and for a like period of time during each and every year thereafter.

REPEALING CLAUSE: All ordinances or parts of Ordinances in . conflict herewith are hereby repealed.

EMERGENCY: Apublic emergency; is not 'deemed to exist at this time and therefore this Ordinance shall not be effective for thirty (30) days from and after the date hereinafter set forth.
