ORDINANCE NO. 328

AN ORDINANCE AMENDING CHAPTER ONE OF TITLE THREE OF THE CITY CODE OF POLSON, 1965, BY AMENDING SECTION 3-1-1 THEREOF PERMITTING THE CONNECTION OF THREE-QUARTER INCH (3/4") WATER METERS TO WATER SERVICES LARGER THAN THREE-QUARTER INCH (3/4") IN SIZE, AND BY AMENDING SECTION 3-1-15 MAKING IT THE FINANCIAL OBLIGATION OF THE WATER USERS BOTH WITHIN AND WITHOUT THE CITY OF POLSON TO PAY FOR THE INSTALLATION OF THE ENTIRE SERVICE FROM THE CITY MAIN TO THE SERVICE PIPELINE OF THE PROPERTY OWNER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 1 of Title 3 of the City Code of Polson, 1965, shall be amended by amending Section 3-1-1 thereof, to read as follows:

3-1-1: The City shall install three-fourths inch (3/4") meters on water service pipes of persons using water from the Waterworks Department of the City. Larger meters shall be paid for by the owner or user. Such meters shall be installed on said service pipes in such manner and place as may be prescribed by the officers of the Waterworks Department, and in addition thereto the Waterworks Department shall have the authority to establish meter service pipes at residences when it shall deem it to the best interest of said Waterworks Department and the Dity. The City Water Superintendent shall have discretionary authority, subject to review by the City Council of this City, to allow property owners to install service lines of a diameter greater than three-fourths inch (3/4") for connection to three-fourths inch (3/4") water meters installed by the City Water Department.

Chapter 1 of Title 3 of the City Code of Polson, 1965, shall be amended by amending Section 3-1-15 thereof, to read as follows:

3-1-15: The service pipe for property, located within and without the City Limits, to the tap in the City water main, together with curb cock and box, will be laid according to City specifications at the expense of the property owner. Once laid and paid for by the owner, the City assumes responsibility from the main to curb shut off.

REPEALING CLAUSE: All Ordinances of parts of Ordinances in conflict herewith are hereby repealed.

EMERGENCY: Apublic emergency is not deemed to exist at this time and therefore this Ordinance shall not be effective for thirty (36) days from and after the date hereinafter set forth.

ORDINANCE NO. 329

AN ORDINANCE AMENDING CHAPTER FOUR OF TITLE NINE OF THE CITY CODE OF POLSON, 1965, BY AUTHORIZING THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, TO ALTER THE CURB LINE IN THE CITY OF POLSON FOR THE PURPOSE OF MAINTAINING AND WIDENING STREETS TO THEIR FULL DEDICATED WIDTH AND BY PROHIBITING THE PLANTING OF TREES OR SHRUBBERY OR STHER VEGETATION IN THE "PARKING STRIP" BETWEEN ANY SIDEWALK AND STREET WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 4 of Title 9 of the City Code of Polson, 1965, shall be amended by amending Section 9-4-4 to read as follows:

9-4-4: CURB LINE--PARKING STRIP: The curb line as now establishd within the City of Polson may be changed, from time to time, as the City Council shall deem necessary in order to re-build, repair, re-pave or widen any of the City streets to the full dedicated width thereof. It is deemed to be in the public interest that there be no further planting of trees, shrubbery, or other vegetation within the parking strip located between any sidewalk and street curb line within the City Limits of the City of Polson, Montana, and therefore, the poanting of any such tree, shrub, or vegetation in any parking strip within the City of Polson, Montana, is hereby specifically prohibited and provided further that the planting of any such tree, shrub provided further that the planting of any such tree, shrub or other plant life in violation of this Ordinance shall be a misdemeanor and may be abated as a public nuisance.

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

EMERGENCY: A public emergency is not deemed to exist at this time and therefore this Ordinance shall not be effective for thirty (30) days from and after the date hereinafter set forth.

> Fifteenth Avenue as described in the plat of the EAST HTLLSIDE ADDITION, according to the official map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

and in the judgment of the City Council of the City of Polson, Montana, it will be to the best interests of the said City and the inhabitants thereof, and the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson, Montana, shall be extended so as to include the hereinbefore described contiguous tracts of land within the corporate

limits thereof;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that it is their intention to extend the boundaries of the City of Polson, Lake County, Montana, so as to include the above-cescribed contiguous tracts of land within the corporate

limits thereof, and;
