## RESOLUTION NO. 328

A RESOLUTION AUTHORIZING FILING OF APPLICATION WITH THE ENVIRONMENTAL PROTECTION AGENCY, AND THE STATE OF MONTANAFOR A WATER POLLUTION CONTROL GRANT.

WHEREAS, under the terms of the Water Pollution Control Act (33 U. S. C. 466 et seq.), the United States of America has authorized the making of grants to authorized applicants too aid in the construction of sewage treatment facility projects,

AND, WHEREAS, the Montana State Board of Health pursuant to Section 69-4808-1 R.C.M., 1947, and House Bill No. 476 of the Forty-second (42nd) Session of the Legislative Assembly of the State of Montana has been authorized to provide grants to authorized applicants to aid in construction of sewage treatment facility projects.

NOW, THEREFORE, be it resolved by the City Council of the City of Polson, Montana, that the duly elected Mayor and duly appointed City Clerk of the City of Polson, Montana, to-wit, NORENE MOSLEY and ARDATH MORTON, are hereby authorized to execute and file applications on behalf of the City of Polson, Montana, with the United States Government, and the State of Montana, for grants to aid in the construction of sewage treatment facility improvements, and they are hereby authorized and directed to furnish such information as the Environmental Protection Agency and the State Department of Health may reasonably request in connection with such applications and to sign all necessary documents.

## ORDINANCE NO. 334

AN ORDINANCE AMENDING CHAPTER 1 OF TITLE 3 OF THE CITY CODE OF POLSON, 1965, BY PROVIDING FOR A DEPOSIT SYSTEM, PROVIDING FOR A GENERAL SERVICE CHARGE POLICY, AND REQUIRING THAT THE COST OF ALL NEW INSTALLATIONS BE PAID IN ADVANCE, AND AMENDING ALL SEC\* TIONS ENCONISTENT WITH SAID PROVISIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Chapter 1 of Title 3 of the City Code of Polson, 1965, shall be amended by the addition of Secion 3-1-30 which shall read as follows:

4-1-30: The follwing deposit schedule shall be applied by th City of Polson Water Department to all water service connections, including original as well as all transfers, subject to the following exceptions. Said schedule is as follows;

## EXCEPTIONS:

The deposit requirment shall not apply to persons who are applying for water service to property which they own;

Provided further, however, that property owners applying for water service who have had a history of delinquent payments to the City of Polson Water Department shall be required to comply with the above deposit schedule in order to obtain a new or transferred water hook-up;

And provided further that fafternwater service has been disconnected for failure to timely pay water charges, the appropriate deposit above enumerated, together with with all arrearages and service charges shall be paid to the City of Polson Water Department before the water service shall be reconnected.

Chapter 1 of Title 3 of the City Code of Polson, 1965, shall beafurtherunmended by the addition of Section 30-1-31 which shall read as follows:

30-1-31: The City of Polson Water Department shall assess a service charge on all service calls at the rate of Two Dollars (\$2.00) per call, including a Two Dollar (\$2.00) charge for each connections, and a Two Dollar (\$2.00) charge for each disconnection from the City Of Polson Water system.

Chapter 1 of Title 3 of the City Code of Polson, 1965, shall be further amemded by the addition of Section 30-1-32 which shall read as follows:

30-1-32: All applications for new service installations shall be referred to the City of Polson Water Superintendent who shall make an actual appraisal of the probable cost of the requested installation. The applicant shall be advised of the said probable cost of installation, and shall, prior to said installation being made by the City of Polson Water Department, deposit the cost thereof with the City of Polson Water Clerk.

Chapter 1 of Title 3, Sections 3-1-10, 3-1-14 and 3-1-28, of the City Code of Polson, 1965, shall be amended by deleting the words "Two Dollars (\$2.00)", and substituting therefor the words "Four Dollars (\$4.00)".

Chapter 1, of Title 3, Section 3-1-22, of the City Code of Polson, 1965, shall be amended by deleting the words "One Dollar (\$1.00)", and substituting the words "Two Dollars (\$2.00)".

REPEALING CLAUSE: All Ordinance or parts of Ordinance in conflict herewith are hereby repealed.

EMERGENCY: A public emergency is hereby declared to exist and this Ordinance is hereby declared to be nesessary for the immediate preservations of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval.
