AN ORDINANCE AMENDING CHAPTER 4 TITLE 9 OF THE CITY CODE OF POLSON, 1965, BY ESTABELISHING THE STREET GRADE FOR THAT PORTION OF SECOND STREET GRADE FOR THAT PORTION OF SECOND STREET WEST SOUTH OF FOHRTEENTH AVENUE WEST FOR A DISTANCE OF ONE THOUSAND FIVE HUNDRED FEET, ALL WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, REPEALING ALL INCONSISTENT ORDINANCES AND DECLARING A PUBLIC EMERGENCY.

WHEREAS, Polson High School District No. 23 has been advised by the City Gouncil of the City of Polson, Montana that it must construct, at its expense, all streets and avenues which will provide access to the new high school facility presently under construction, and;

WHEREAS, said construction must be completed according to City specifications, including construction of the streets and avenues to the grade established by the City of Polson, and, whereas, the grade for the extension of Second Street West in a southerly direction for a distance of One Thousand Five Hundred (1,500) feet from Fourteenth Avenue West has been established by Michael Mattovic, Professional Engineer, Engineer License No. 175 E.S., and;

Whereas, said street grade as established, is particularly described on that certain "Road Grade Profile" which is attached hereto as Exhibit "A" and by this reference made a part hereof as though set forth fully at this place, which profile consists of four sheets and is indentified by the signature of the said Michael Mattovich under date of April 16, 1973.

NOW THEREFORE, be it ordained by the City Council of the City of Polson, Montana:

That Chapter 4 of Title 9 of the City Code of Polson, Montana, 1965, shall be amended by the addition of Section 9-4-1-(A) which shall read as follows;

9-4-1-(A): The grade for that portion of Second Street West which lies South of Fourteenth Avenue West, for a distance of one thousand fire hundred (1,500) feet, shall be, and the same is hereby declared to be the grade profile as set forth in that certain "Road Grade Profile" prepared at the request of the City of Polson by Michael Mattovich, Professional Engineer No. 175 E.S., consisting of four sheets which have been designated as Exhibit "A" and are further identified by the signature of the said Michael Mattovich under date of April 16, 1973. A copy of said Road Grade Profile is on file at the office of the City Clerk of the City of Polson, Montana, and is attached as Exhibit "A" to Ordinance No. 341.

REPEALING CLAUSE: All Ordinances or parts of Ordinances in conflict therewith are hereby repealed.

EMERGENCY: A public emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after passage and approval.
