AN ORDINANCE AMENDING CHAPTER 1 OF TITLE III OF THE CITY CODE OF POISON, 1967, BY PROVIDING FOR A REVISED WATER RATE SCHEDULE AND AMENDING ALL SECTIONS IN* CONSISTENT WITH SAID PROVISIONS.

BE IT ORDAINED by the City Council of the City of Polson, Montana;

Chapter 1 of Title III of the City Code of Polson, 1965, shall be amended by addition of Section 3-1-33 which shall read as follows:

3-1-33: The following water rate schedule shall be applied by the City Cofy Polson's water department to all water service connections;

Minimum Residential is \$7.00 for 5000 Gallons Minimum Commercial is \$8.75 for 5000 Gallons

The above water rate schedule will become effective thirty (30) days after the sale of revenue bonds which are being sold for the purpose of removating and updating the existing City of Polson water supply works.

PROVIDED FURTHER, that if the Montana Public Service Commission should determine prior to approving said water rates that minor alterations or amendments should be made in the public interest, the authority is hereby reserved by the City Council of the City of Polsonk Montana, to adopt the alterations and amendments imposed by the Public Service Commission without further notice of public hearing.

A formal public hearing relative to the aforesaid rate schedule will be conducted at the City Council chambers of the City Hall, Polson, Montana, commencing at 8:00 p. m., Monday, December 15, 1975. All persons who are users of the City of Polson water services who are interested may attend and present sworn testimony, either for or against the said rate schedule or any facet thereof.

PROVIDED FURTHER, that the transcript of the aforesaid hearing, together with a copy of this Ordinance and proof of publication of notice of said hearing shall be presented texthexpresented to the Montana Public Service Commission for its examination and approval, alteration, amendment or rejection of said rate schedule.

This notice shall be published in the Flathead Courier, a newspaper of general circulation in the City of Polson, Montana, on November 20, 1975, and November 27, 1975, and December 4, 1975, and December 11, 1975.

REPEALING CLAUSE: All ordinance or parts of ordinances in conflect herewith are hereby repealed.
