AN ORDINANCE AMENDING CHAPTER TWO OF TITLE TEN OF THE CITY CODE OF POLSON, MONTANA, 1965

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA

Section 3 Chapter 1 of Title 6 of the City Code of Polson, 1965, shall be amended to read as follows:

- Assault: (1) A person commits the offense of assault if he:
- (a) purposely or knowingly causes bodily injury with a weapon, or
- (b) negligently causes bodily injury to another with a weapon; or
- (c) purposely or knowingly makes pjysical contact of an insulting or provoking nature with any individual; or
- (d) purposely or knowingly causes reasonable apprehension of bodily injury in another. The purpose to cause reasonable apprehension or the knowledg that reasonable apprehension would be caused shall be presumed in any case in which a person knowingly points a firearm at or in the direction of another whether or not the offender believes the firearm to be loaded.
- A person convicted of asault shall be fined not to exceed Three Hundred and no/100ths Dollars (\$300.00) or to be imprisoned in the county jail for any term not to exceed three (3) months, or both.

REPEALING CLAUSE: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

EMERGENCY: A public emergency is hereby declared to exist and this Ordinanc is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after passage and approval.

## ORDINANCE NO. 366

AN ORDINANCE AMENDING CHAPTER TWO OF TITLE TEN OF THE CITY CODE OF POLSON, MONTANA, 1965, BY ADJUSTING THE VEHICLE RIGHT-OF-WAY REGULATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA

Section 15 Chapter 2 of Title 10 Cof the City Code of Polson, 1965, shall read and be amended as follows:

10-2-15 (H): Right-of-way. The driver of a vehicle approaching an intersection shall yield the right-of-way to a vehicle which has entered the intersection from a different highway.

Wh n two (2) vehicle s enter or approach an intersection from different streets at approximately the same time, the driver of the vehicle on the left shall yield the right-of-way to the vehicle on the right.

The right-of-way rules declared in this Subsection are modified at through streets and otherwise are hereinafter stated in this Section.

10-2-15 (K): Vehicle Entering Street or Highway from Parked Position, Alley, Private Road or Driveway; The driver of a vehicle about to enter or cross a street or highway from a parked position, alley, private road or driveway shall yield the righ-of-way to all vehicles approaching on said street or highway.

10-2-15 (L): Limitations on Backing: The driver of a vehicle shall not back the same unless such movement can be made with reasonable safety and without interfering with other traffic.

REPEALING CLAUSE: All ordinances or parts of ordinances in conflect herewith are hereby repealed.

A public emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after passage and approval.
