ORDINANCE NO. 367

AN ORDINANCE AMENDING CHAPTER FIVE OF TITLE THREE OF THE CITY CODE OF POLSON, MONTANA, 1965.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA

Section 3 Chaper 5 of Title 3 of the City Code of Polson, 1965 shall read and be amended as follows:

3-5-3: Rates of Rental: Every person or persons, company or corporation contracting with the City for the use of the City sewer system shall be required to pay as rental therefor the following rates: Twenty-five percent (25%) of the average of the individual monthly water charges for the previous period that are dommenced October 1 and ended April 1; said monthly water charges are determined by applying the water rate schedule in effect through the billing period to the individual monthly water consumptions for the period of October 1 through April 1.

REPEALING CLAUSE: All ordinances or parts of ordinancessin conflict herewith are hereby repealed.

EMERGENCY: A public emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after passage and approval.

RESOLUTION OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POLSON, MONTANA, AND TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED WHICH ARE CONTIGUOUS TO THE CITY OF POLSON, MONTANA.
