

AN ORDINANCE AMENDING CHAPTER 3 TITLE VI OF THE CODE OF THE CITY OF POLSON, 1965, BY REPEALING SECTION 6-3-9 AND SECTION 6-3-14 BECAUSE THEY ARE IN CONFLICT WITH SECTION 6-3-6 AND RENUMBERING THE REMAINING SECTIONS AS A RESULT THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

CHAPTER 3 OF TITLE VI, Section 6-3-9 and Section 6-3-14 shall be repealed:
