AN ORDINANCE REPEALING CHAPTER 18 TITLE I OF THE CODE OF THE CITY OF POLSON, 1965, BY REPEALING SECTION 1-18-1, 1-18-2 and 1-18-3 BECAUSE OF AMENDMENTS TO CHAPTER 3 TITLE VI.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

CHAPTER 18 OF TITLE I, Section 1-18-1, 1-18-2 and 1-18-3 shall be repealed:

1-18-1: APPOINTMENT: -- The - Mayor - with - the - advice and - consent - of - the - Council - may - appoint - a - Poundmaster - who shall - establish; - at - the - City's - expense; - a - pound.

1-18-2: DUTIES:--(a)--It-shall-be-the-duty-of the-Poundmaster-to-take-up-and-impound-every-dog-running at-large-contrary-to-the-provisions-of-this-Chapter.--If an-impounded-dog-be-not-redeemed-within-fortyeight-(48) hours-after-said-dog-is-impounded;-the-Poundmaster-shall give-notice-of-such-impounding-to-the-owner-in-the-manner prescribed-by-the-baws-of-the-State-of-Montana-after which;-and-in-conformity-thereto;-the-Poundmaster-shall offer-the-impounded-dog-for-sale;-and-if-no-bid;-equalling or-exceeding-the-sum-of-all-fees-provided-for-by-this Code;-including-but-not-limited-to-those-assessed-for-the impounding-and-keeping;-is-received-therefore;-the impounded-dog-shall-be-killed-by-him:--(Ordinance-No:-345)

(b)--It-shall-be-the-duty-of-the-Pound-master-to-enforce-the-provisions-of-Chapter-3-which-shall include-the-authority-to-issue-citations-for-violation thereof-as-set-forth-in-Section-6-3-19.

1-18-3: APPOINTMENT-OF-ACTING-POUNDMASTER:--In the-event-that-no-appointment-is-made-to-the-office-of Poundmaster;-the-Mayor-with-the-advice-and-consent-of the-Council-may-appoint-an-acting-Poundmaster-for-any specific-purpose-and-may-provide-for-compensation-of-such-acting-Poundmaster:--In-the-event-no-Poundmaster-is appointed;-the-Chief-of-Police-will-act-in-emergencies:

REPEALING CLAUSE: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
