## RESOLUTION NO. 155

A RESOLUTION REVISING AND INCREASING THE ASSESSMENT UPON THE PROPERTY WITHIN SPECIAL IMPROVEMENT DISTRICT NO. 17 OF THE CITY OF POLSON, MONTANA, SO AS TO SECURE BUFFICIENT FUNDS TO RETIRE THE SPECIAL INFORMERT DISTRICT BONDS AGAINST SAID DISTRICT.

BE IT RESOLVED BY THE CITY COUNCIL OF POLSON, MCNTANA, THAT:

WHEREAS, on April 1, 1952, the City Council passed and approved Resolution No. 125, creating Special Improvement District No. 17 and

MEREAS, special improvement district bonds in the amount of \$26,400.00 were issued for the purpose of paying for the improvements in said Special Improvement District No. 17, and

WHEREAS, said resolution provided that the cost would be approximately \$137.50 per 25-foot frontage against the property, within said District, and

MEREAS, by reason of certain omissions and irregularities in said Resolution No. 125, the assessment made therein was not sufficient to retire said Special Improvement District Bonds by their maturity date of April 1, 1962, and it is necessary to make additional assessments upon the property within said Special Improvement District for the purpose of securing such funds,
