

RESOLUTION No. 164

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, TO ENACT AN ORDINANCE CREATING A PLANNING BOARD UNDER AND PURSUANT TO CHAPTER 246 OF THE LAWS OF THE 35th. LEGISLATIVE ASSEMBLY OF THE STATE OF MONTANA, AND DIRECTING THE CITY CLERK TO NOTIFY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF LAKE, MONTANA.

WHEREAS, the Council of the city of Polson, Montana, has determined, and does hereby determine that good cause and reason exist to create a City Planning Board, as set forth above and the same will be of benefit to the community and can be done without detriment to the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

That it now has under consideration and intends to enact an Ordinance creating a City Planning Board under and pursuant to Chapter 246 of the Laws of the 35th. Legislative assembly of the State of Montana, and,

Be it further resolved that the City Clerk be, and he hereby is directed to notify the Board of County Commissioners of Lake County, Montana, of the intention of the Council so to do, as required by Section 5 of the said Chapter 246 of the Laws of 1957.

That this Resolution shall take effect and be in full force from and immediately after its approval.

RESOLUTION No. 165

A RESOLUTION DECLARING AN EMERGENCY AND MAKING AN EMERGENCY APPROPRIATION FOR THE MAINTENANCE AND OPERATION OF THE POLICE DEPARTMENT OF THE CITY OF POLSON, MONTANA.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA THAT:

WHEREAS, subsequent to the adoption of the budget for the City of Polson, for the fiscal year <sup>65.66</sup> ~~1958-1959~~, conditions have developed, and policies have been adopted to meet the said conditions, which were not foreseeable at the time of the adoption of the said budget, and which have necessitated the expenditure of more money, by the police department, than was provided by the said budget, and

WHEREAS, the money appropriated by the said budget, for the Police Department, has been virtually all expended, and there will not be sufficient fund for the Police Department for the balance of the fiscal year without an additional appropriation, and

WHEREAS, the continued operation of the Police Department, of the said City of Polson, Montana, is necessary for the ~~public interest~~ preservation of the public peace and to insure the public safety, and

WHEREAS, an immediate public emergency exists by reason of the said lack of sufficient funds in the budget for the continued operation of the said Police Department;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, THAT THE AMOUNT OF Four Thousand dollars (\$4,000.00), the amount of money necessary to meet such emergency, be issued against the General Fund (Police Department) as emergency warrants, for the purpose of operating the Police Department for the balance of the fiscal year 1958-1959, and that a public hearing be held on the final adoption of this Resolution, as provided by law.
