RESOMUTION No. 165

ARESOLUTION DECLARING AN EMERGENCY AND MAKING AN EMERGENCY APPROPRIATION FOR THE MAINTENANCE AND OPERATION OF THE POLICE DEPARTMENT OF THE CITY OF POLSON, MONTANA.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA 55.66

WHEREAS, subsequent to the adoption of the budget for the City of Polson, for the fiscal year 1958-159, conditions have developed, and policies have been adopted to meet the said conditions, which were not forseeable at the time of the adoption of the said budget, and which have necessitated the expenditure of more money, by the police department, than was provided by the said budget and by the said budget, and

WHEREAS, the money appropriated by the said budget, for the Police repartment, has been virtually all expended, and there will not be sufficient fund for the Police Department for the balance of the fiscal year

without an additional appropriation, and

WHEREAS, the continued operation of the Police Department, of the said City of Polson, Montana, is necessary for the public xprise preser vation of the public peace and to insure the public safety,

WHEREAS, an immediate public imergency exists by reason of the said lack of sufficient funds in the budget for the continued operation

of the said Police Department;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PCLSON, MONTANA, THAT THE AMOUNT OF Four Thousand dollars (\$4,000.00), the amount of money necessary to meet such emergency, be issued against the General Fund (Police Department) as emergency warrants, for the purpose of operating the Police Department for the ballance of the fiscal year 1958-159, and that a public hearing be held on the final adoption of this Resolution, as provided by law.
