A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON SO AS TO INCLUDE HILLVIEW HEIGHTS ADDITION, AN ADDITION TO POLSON, THEREIN, WHICH ADDITION IS CONTIGUOUS TO THE CITY OF POLSON.

WHEREAS, The City Council of the City of Polson, Montana, on the 6th day of July, 1959, duly and regularly passed a resolution proposing to extend the corporate limits of the City of Polson so as to include Hillview Heights Addition therein, and declaring it to be to the best interests of the City of Polson and the inhabitants thereof and of the inhabitants of said territory or parcel of land, as aforesaid, that the boundaries of the City of Polson shall be extended so as to include the same within the corporate limits thereof, and

WHEREAS, The City Council has caused to be published in The Flathead Courier, the newspaper published nearest said Addition, at least once a week for two successive weeks, a notice to the effect that this resolution has been duly and regularly passed and that for a period of twenty days after the publication of said notice, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson from freeholders of the territory proposed to be embraced therein, and the property holders therein to be notified in writing, and

WHEREAS, The City Clerk has received no communications in writing relative to the proposed extensions.

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of Polson that the boundaries of the City of Polson, Montana, shall be extended, and the same are hereby extended, so as to include within the corporate limits of said City the said platted tract of land described as follows, to-wit:

HILLVIEW HEIGHTS ADDITION, an addition to the City of Polson, Lake County, Montana, all as further appears from the map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana.
