

RESOLUTION NO. 180

A RESOLUTION OF THE CITY COUNCIL OF POLSON, MONTANA, PROVIDING FOR TAPS INTO THE SUPPLY LINE FOR THE CITY WATER SYSTEM; ESTABLISHING THE NUMBER OF SUCH TAPS, AND AMENDING THE SCHEDULE OF RATES AND REGULATIONS.

BE IT RESOLVED, by the City Council of the City of Polson, Montana, that,

SECTION L. WHEREAS, On July 5th, 1961, the City Council adopted a Motion to permit not to exceed 10 - 3/4" tap-ins to be made in the main water supply line from the Hell Roaring Creek Inlet to the City limits, for the year, 1961, and

WHEREAS, said City Council has been advised by the Montana Public Service Commission that such regulations can be made a part of Order No. 2813 of said Montana Public Service Commission, fixing the rates and regulations for the said City Water system;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that the Schedule and regulations of said City be amended so as to include the provision that not more than 10 - 3/4" taps be made to said supply line during the year 1961. .

BE IT FURTHER RESOLVED that the Montana Public Service Commission be, and IT IS HEREBY REQUESTED to include such provision and regulations within the Schedule of Rates and Regulations #2813 adopted by said Montana Public Service Commission.

RESOLUTION NO. 181

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, DECLARING ITS INTENTION TO VACATE 3RD STREET EAST BETWEEN A POINT 100 FEET NORTH OF 10TH AVENUE EAST AND 11TH AVENUE EAST, AND 10TH AVENUE EAST BETWEEN SECOND STREET EAST AND THE ALLEY BLOCK TWO (2) of POLSON CITY CENTER ADDITION TO POLSON, MONTANA.

WHEREAS, the City of Polson, Montana, is now the owners of Blocks Six (6) and Seven (7) and Lots Twenty-two (22) through Twenty-nine (29), inclusive, of Block Three (3), and Lots ~~Twenty-two~~ (22) through Twenty-five (25) inclusive of Block Two (2), all in Polson City Center Addition to Polson, Montana, which Blocks are separated by 3rd Street East, and,

WHEREAS, it is the desire of said City Council to develop both of said blocks and said Lots, as a recreational area, and to do so it would require the vacation of 3rd Street East between a point 100 feet north of 10th Avenue East and the South boundary line of 11th Avenue East; and all of the alley in said Block Six (6) and the south 100 feet of the alley in said Block Three (3), and 10th Avenue East between Second Street East and the alley in Block Two (2), of Polson City Center Addition.

WHEREAS, the statutes of the State of Montana require notice to be given,

NOW, THEREFORE, BE IT RESOLVED, that a notice be published or posted in three (3) public places stating that the final determination of the abandonment of said street will be held on the 2nd day of October, 1961, at the City Hall, in the City of Polson, Montana, when and where any persons interested may appear and be heard for or against the abandonment of the said street, and the City Clerk is hereby directed to give such notice as required by law.
