

A RESOLUTION OF THE POLSON, MONTANA CITY COUNCIL DECLARING ITS INTENTION OF CLOSING, VACATING AND ABANDONING THAT PART OF FIRST STREET WEST BETWEEN THE SOUTH LINE OF EIGHTH AVENUE AND THE NORTH LINE OF ELEVENTH AVENUE; AND THOSE PARTS OF NINTH AVENUE, TENTH AVENUE, AND THE ALLEYS IN BLOCKS NUMBERED THREE (3), FOUR (4), SEVEN (7), EIGHT (8), NINE (9), AND TEN (10) ALL FROM THE WEST LINE OF SECOND STREET WEST TO THE WEST LINE OF LOTS NUMBERED FOUR (4) AND NINE (9) IN BLOCKS NUMBERED FOUR (4), SEVEN (7), AND TEN (10) RESPECTIVELY, A DISTANCE OF SIX HUNDRED THIRTY FEET (630'), MORE OR LESS, ALL IN CENTRAL ADDITION TO THE CITY OF POLSON, MONTANA, SUBJECT ONLY TO RIGHTS OF EXISTING PUBLIC UTILITIES.

WHEREAS, School District Number twenty-three (23), Lake County, Montana is the sole owner of all of Blocks numbered Three (3), Eight (8), and Nine (9), and lots numbered Four (4) thru Nine (9) inclusive in each of the Blocks numbered Four (4), Seven (7), and Ten (10), all in Central Addition to the City of Polson, Montana, and

WHEREAS, it is the desire and intention of the said School District to develop all of said lots and blocks for purposes of a school and necessary appurtenances thereto, and

WHEREAS, the School Board of said School District Number 23 deems it necessary that certain public thoroughfares, hereinafter described, be vacated and abandoned and closed to public traffic in order to accomplish said purpose, and has so notified the City Council in writing, and


WHEREAS, the City Council believes that the closing of said public thoroughfares is in the public interest, and

WHEREAS, the statutes of the State of Montana require that notice be given,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA that, it is the intention of the said City Council that the following described public thoroughfares be vacated, abandoned, and closed to public traffic, subject only to the rights of existing public utilities: First Street West between the south line of Eighth Avenue and the north line of Eleventh Avenue; and those parts of Ninth Avenue, Tenth Avenue, and the alleys in Blocks numbered Three (3), Four (4), Seven (7), Eight (8), Nine (9), and Ten (10) of Central Addition to the City of Polson, all from the west line of Second Street West to the west line of Lots numbered four (4) and Nine (9) in Blocks numbered Four (4), seven (7), and Ten (10) respectively, a distance of six-hundred-thirty feet (630'), more or less, all in Central Addition to the City of Polson, and

BE IT FURTHER RESOLVED that a notice be published or posted in three public places stating that the final determination of the abandonment of said street, avenues, and alleys will be held on the 21st day of May, 1962, at 7:30 p.m., at the City Hall in the City of Polson, Montana, when and where any persons interested may appear and be heard for or against the abandonment of said street, avenues, and alleys, and the City Clerk is hereby directed to give such notice as required by law.
