

RESOLUTION NO. 191

A RESOLUTION PROPOSING TO EXTEND THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THOSE CERTAIN TRACTS OF LAND OR PARCELS OF LAND HEREINAFTER DESCRIBED, WHICH ARE CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, it appears to the Mayor and the City Council of the City of Polson, Montana, it will be to the best interests of the City of Polson, Montana, and the inhabitants thereof and of all of the inhabitants of the said territory or parcels of land, as aforesaid, that the boundaries of the City of Polson, Montana, shall be extended so as to include the same within the corporate limits thereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana, that it is the judgment of said Council that it will be to the best interests of the City of Polson, Montana, and the inhabitants thereof and of the inhabitants of said territory or parcels of land, as aforesaid, and hereinafter described that the boundaries of the said City of Polson be extended so as to include within the corporate limits of said City, the following described tracts of land, contiguous to the City of Polson, Montana:

A tract of land located in Section Three (3), Township Twenty-two (22) North, Range Twenty (20) West, Lake County, Montana, more particularly described as follows:

Beginning at a point at the intersection of the present Polson City Limits Line and the North property line of Seventh Avenue, said point of beginning being 45.0 feet north of the 1/16 corner on the south section line of Section Three (3), said 1/16 corner being 1324.4 feet from the southwest Section Corner of Section Three (3); thence from said point of beginning a distance of 680 feet in a northerly direction along the present Polson City Limits Line to the intersection of the south property line of Fifth Avenue; thence easterly along the south property line of Fifth Avenue and the present Polson City Limits Line a distance of 407.8 feet to the east boundary of the Cass Addition; thence northerly along the present Polson City Limits Line and the east boundary of the Cass Addition a distance of 380 feet to the intersection of the south property line of Fourth Avenue; thence westerly along the south property line of Fourth Avenue and the present Polson City Limits Line a distance of 407.8 feet to the northwest corner of the Cass Addition; thence northerly along the present Polson City Limits line a distance of 328.4 feet to a point near the Flathead Lake shoreline; thence S 81° 30' E. a distance of 636.6 feet; thence N 48° 00' E, a distance of 831.6 feet; thence S 72° 00' E a distance of 528.0 feet; thence N 85° 00' E a distance of 660.0 feet; thence N 73° 00' E a distance of 574.2 feet; thence N 76° 00' E a distance of 541.2 feet; thence N 28° 15' E a distance of 580.8 feet; thence N. 09° 00' E a distance of 528.0 feet; thence N 25° 00' E a distance of 264.0 feet to the intersection of the east Section Line of Section Three (3); thence southerly along the east Section Line of said Section three (3), to the intersection of said Section Line with the northerly right-of-way line of the Northern Pacific Railway Company, thence westerly following the Northern Pacific Railway Company right-of-way line to the intersection of said right-of-way line with the north property line of Seventh Avenue Extended; thence westerly along the north property line of Seventh Avenue Extended, to the intersection of the present Polson City Limits Line, said intersection being the point of beginning of this description.

BE IT FURTHER RESOLVED that the City Clerk shall forthwith notify in writing all property holders within the boundaries of said territory and cause to be published in the Flathead Courier, the newspaper published nearest such tracts or parcels of land, at least once a week for two successive weeks, a notice to the effect that this Resolution has been duly and regularly passed, and that for a period of twenty (20) days after the first publication of said notice, said City Clerk will receive expressions of approval or disapproval, in writing, of the proposed extension of the boundaries of the City of Polson, Montana, from the free-holders of the territory proposed to be embraced therein.
