

RESOLUTION NO. 200.

A RESOLUTION GRANTING GRAY COMPANY AN EXTENSION OF THIRTY (30) DAYS ADDITIONAL TIME WITHIN WHICH TO COMPLETE THE CONSTRUCTION OS SANITARY SEWER IMPROVEMENTS (SID NO. 11).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA.

L. THAT THE City of Polson grant the Gray Company an extension of thirty (30) days, to Saturday, October 26, 1963, at twelve o'clock midnight, within which to complete the construction of sanitary sewer improvements (SID No. 11), HHFA Project No. APW Montana 5G, provided that the City of Polson is reimbursed for any and all cost of every kind and nature occasioned by such extension.

RESOLUTION NO. 201.

A RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE CITY OF POLSON, LAKE COUNTY, MONTANA. SO AS TO INCLUDE TWO CONTIGUOUS TRACTS OF LAND HEREINAFTER DESCRIBED WITHIN THE CORPORATE LIMITS OF THE CITY OF POLSON.

WHEREAS, The city of Polson Council of the City of Polson, Montana, on the 4th day of March, 1963, duly and regularly passed a Resolution proposing to extend the corporate limits of the City of Polson so as to include two contiguous tracts of land and declaring it to be for the best interest of the City of Polson, and the inhabitants thereof, and of the inhabitants of said territory or parcels of land, as aforesaid, that the boundaries of the City of Polson shall be extended so as to include the same within the corporate limits thereof; and

WHEREAS, The City of Polson Council has caused to be published in the Flathead courier. the newspaper published nearest said tracts of land. at least once a week for two successive weeks, a notice to the effect that said resolution had been duly and regularly passed and that for a period of twenty days after the first publication of said notice, the City Clerk will receive expressions of approval or disapproval, in writing, of the proposed extension of the boundaries of the City of Polson from freeholders of the territory proposed to be embraced therein, and the property holders therein be notified in writing, and

WHEREAS, The City Clerk has received no communications in writing relative to the proposed extension.

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of Polson, that the boundaries of the City of polson, Montana shall be extended, and the same are hereby extended so as to include within the corporate limits of said city the said tracts of land described as follows, to wit:

A fractional part of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section (10) Ten, Township Twenty-Two (22) North, Range 20 (20) West, M. P. M. , described as follows: Beginning at the Northeast corner of Block Twenty-eight (28) of Grandview Addition to Polson, Montana, and running thence S. 89° 58' E. 200 feet; thence S. 0° 03' W. 122 feet; thence S. 45° 10' W. 49 feet; thence N. 89° 58' W. 164.8 feet; thence N. 0° 03' W. 156.1 feet to the place of beginning; and Lot Five (5) of Block Two (2) of HILLSIDE ADDITION to Polson, Montana.
