## RESOLUTION NO. 202.

A RESOLUTION REPEALING RESOLUTION NO. 183, PASSED AND APPROVED ON MAY 7th, 1962, AND RESOLUTION NO. 184, PASSED AND APPROVED ON JUNE 4, 1963, RELATING TO VACATING CERTAIN STREETS AND ALLEYS IN CENTRAL ADDITION.

WHEREAS, It now appears that no sufficient petition was presented to this Council prior to the passage of Resolution No. 183; and

WHEREAS, No petition signed by seventy-five percent (75%) of the lot owners on the said streets and alleys to be closed was

presented to the Council, as required by Section 11-2801 of the Revised Codes of Montana, 1947; and
WHEREAS, The description of the alleys closed by Resolution no. 184, is different than the description of the alleys contained in Resolution No. 183 and is different than the description contained in the resolution published by order of the council; and

WHEREAS, It appears that the said Resolutions were illegally

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

1. That Resolution No. 183 and Resolution No. 184 of the

City of Polson be, and the same are hereby, repealed.
2. That the streetsand alleys described in said Resolu-

tions be, and the same are hereby, opened to public traffic.

3. That The Council hereby declares that an emergency exists and that this resolution is necessary for the preservation of peace health and safety, of the inhabitants of the City of Polson and, therefore, shall be in full force and effect immediately after its passage and approval.
