

RESOLUTION NO. 204.

A RESOLUTION DECLARING AN EMERGENCY AND MAKING AN EMERGENCY<sup>33</sup> APPROPRIATION FOR THE OPERATION OF THE CITY DOG POUND AND FOR THE PAYMENT OF THE SALARY OF THE CITY POUND MASTER.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, THAT:

WHEREAS; An immediate public emergency exists, because of the fact that at the time of the adaption of our fiscal year, 1963-1964, insufficient provisions were made for the maintenance of the City Dog Pound and payment of the salary of the City Pound Master; and

WHEREAS; It is necessary for the immediate preservation of order and public peace to employ a City Pound Master, maintain the City Dog Pound and provide for the enforcement of the City Dog Ordinance; and

WHEREAS; There are not sufficient funds in the General Fund to meet the emergency and to enforce said Ordinance;

NOW, THEREFORE, BE IT RESOLVED, That emergency warrents in the amount of Two Hundred Fifty (\$250.00) Dollars be issued against the general Fund for the purpose of paying for the maintenance of said City Dog Pound, the payment of the Pound Master and the enforcement of the Dog Ordinance; and that public hearing be held on the final adaption of this RESOLUTION as provided by law.



RESOLUTION NO. 205.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, PROVIDING FOR ISSUANCE TO JOHN MATOVACK OF REPLACEMENT BONDS NUMBERED 61, 62, 63, 64, S.I.D. No. 10

WHEREAS , It appears to the satisfaction of the City Council of the City of Polson, Montana, by Affidavit of John Matovack, that Bonds S.I.D. No. 10, Sewer Bonds No. 61, 62, 63 and 64, were destroyed in the fire at his residence, and

WHEREAS, Mr. Matovack has furnished the City of Polson, with a surety bond covering the amount of the S.I.D. Bonds lost, executed by an acceptable surety company.


