

RESOLUTION OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POLSON, MONTANA, AND TO INCLUDE TWO CONTIGUOUS TRACTS OF LAND WITHIN THE CORPORATE LIMITS THEREOF

WHEREAS, Calvin T. Christian, and Marva K. Christian, husband and wife, of Polson, Montana, and Steve Symionow and Margaret Eleanor Symionow, husband and wife, of Polson, Montana, the owners of the herein after described tracts of land contiguous to the City of Polson, Lake County, Montana. have requested that the City of Polson extend its boundaries so as to include said tracts of land within the corporate limits of the City of Polson, ~~Lake~~ Lake, County, Montana; and

WHEREAS, the City Council of the City of Polson at a regular meeting held on June 1, 1964, at the City Hall in the City of Polson, Montana, duly considered the question of extending the boundaries of the City of Polson to include the contiguous tracts of land herein after described, and

WHEREAS, it appearing to the City Council of the City of Polson, Montana, that the following tracts of land are contiguous to the City of Polson, Montana, to-wit:

Lot 6 of Block 2, Hillside Addition to Polson, Montana, and

Lot 7 of Block 2, Hillside Addition to Polson, Montana,

and in the judgment of the City Council of the City of Polson, Montana, it will be to the best interests of the said city and the inhabitants thereof, and the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson, Montana, shall be extended so as to include the hereinbefore described contiguous tracts of land within the corporate limits thereof;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Lake County, Montana, that it is their intention to extend the boundaries of the City of Polson, Montana, so as to include the above described contiguous tracts of land within the corporate limits thereof; and

BE IT FURTHER RESOLVED that in the judgment of the City Council of the City of Polson, Montana. it will be to the best interests of the City and the inhabitants thereof, and in the best interests of the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson Montana.

BE IT FURTHER RESOLVED that the City Clerk of the City of Polson Montana forthwith notify in writing all property holders within the boundaries of the herein before described tracts of land. and cause to be published in the Flathead Courier a newspaper published in the City of Polson once a week for two successive weeks. a notice of passage of this resolution which notice shall further state that for a period of twenty days after the publication thereof the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson. Montana. as in this resolution provided. from free holders of the territories herein proposed to be embraced in the corporate limits of the City of Polson. Montana.

The foregoing resolution was duly and regularly passed by the City Council of Polson Montana. and adopted and approved by the Mayor of the City of Polson this 15th day of June. 1964.
