BE IT FURTHER RESOLVED that in the judgment of the City
Council of the City of Polson, Montana. it will be to the best
interests of the City and the inhabitants thereof, and in the
best interests of the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson Montana.

BE IT FURTHER RESOLVED that the City Velerk of the City of Polson Montana forthwith notify in writing all property holders within the boundaries of the herein before described tracts ofland. and cause to be published in the Flathead Courier a newspaper published in the City of Polson once a week for two suc= cessive weeks. a notice of passage of this resolution which notice shall further state that for a period of twenty days after the publication thereof the City Clerk will receive expressions of approval or disapproval in writing of the proposed extention of the boundaries of the City of Polson. Montana. as in this resolution provided. from free holders of the territories herein proposed to be embraced in the corporate limits of the City of

Polson. montana.

The foregoing resolution was duly and regularly passed by the City Council of Polson Montana. and adopted and approved by the Mayor of the City of Polson this 15th day of June. 1964.
