## RESOLUTION NO. 211.

RESOLUTION OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POLSON, MONTANA, AND TO INCLUDE A CONTIGUOUS TRACT OF LAND WITHIN THE CORPORATE LIMITS THEREOF.

WHEREAS, ERIC L. ERICKSON AND VERA B. ERICKSON, husband and wife, of Polson, Montana, the owners of the hereinafter described tract of land contiguous to the City of Polson,

AND BE IT FURTHER RESOLVED, That in the judgement of the City Council of the City of Polson, Montana, it will be in the best interests of said city and its inhaditants thereof and in the best interest of the inhabitants of the hereinbefore described contiguous tract that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson, Montana.

BE IT FURTHER RESOLVED, That the City Clerk of the City of

Montana, forthwith notify, in writing, all property holders within the boundaries of the hereinbefore described teact of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson, Montana, once a week for two (2) successive weeks, a notice of passage of this Resolution which notice shall further state that for a period of twenty (20) days after the first publication thereof, that the City Clerk will receive expressions of approval or disapproval, in writing, of the proposed extention of the boundaries of the City of Polson, Montana, as in this Resolution provided, from freeholders of the territories herein proposed to be embraced in the corporate limits of the City of Polson, Montana.
