

RESOLUTION NO. 212.

A RESOLUTION ALLOWING MORE TAPS AND ENLARGING OF ANY EXISTING TAPS ON THE WATER SUPPLY LINE FROM HELL ROARING I INTAKE TO THE RESERVOIRS OF POLSON,

WHEREAS, The City of Polson has cause to be made two (2) surveys by qualified engineers relative to the allowance of tap-ins on the Hell Roaring Line and;

whereas, Both engineers reports relate that tap-ins do not materially affect the Hell Roaring Line and;


WHEREAS, The City of Polson has been instructed by the Montana Public Utilities Commission to allow more tap-ins to be granted on Hell Roaring Line;



RESOLUTION NO. 213.

A RESOLUTION DECLARING AN EMERGENCY AND MAKING AN EMERGENCY APPROPRIATION FOR MAINTENANCE AND OPERATION UNDER THE PARK FUND TO BE USED FOR MAINTENANCE AND OPERATION FOR THE CITY OF POLSON,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA.

WHEREAS; An immediate public emergency exists, because of various expenditures which could not have reasonably been foreseen at the time of making the annual budget;

WHEREAS; it is necessary for the immediate preservation of order and park maintenance for the City of Polson to expend additional funds, and


WHEREAS; There are not sufficient funds in the Park Fund under maintenance and Operation to meet the current need and existing emergency;


NOW, THEREFORE, BE IT RESOLVED., That warrents in the amount of Two Thousand Five Hundred and no/100 (\$2,500.00) Dollars be issued and registered as necessary against the Park Fund for the purpose of paying for the maintenance and Operation of the City of Polson, and

THAT, a public hearing be held on the final adoption of this Resolution as Provided by law on June 7, 1965, after publication of notice one week in the Flathead Courier, the weekly newspaper in the City of Polson, Lake County, Montana.
