## RESOLUTION NO. 221.

A RESOLUTION AUTHORIZING THE CITY ATTORNEY OF THE CITY OF POLSON, MONTANA. TO CONDEMN APPROXIMATELY 30 ACRES OF GROUND FOR AIRPORT PURPOSES.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON,

MONTANA, THAT:

WHEREAS, the City Council has previously passed resolutions for the extending of the City Airport runway pursuant to the plans of the Joinr Airport Board, and

WHEREAS, the City of Polson, has offered to purchase approximately 20 acres of ground, more particularly described as follows, to-wit:

A tract of land in the  $S^{\frac{1}{2}}$  of the NE $^{\frac{1}{4}}$  of Section 5, T 22 N, R 20 W, Montana Principal Meridian, Lake County, Montana. and more particularly described as follows:

Beginning at the center of Section 5, T 22 N, R 20 W; thence S 89\* 43\* E along the south line of said NE<sup>1</sup>/<sub>4</sub> 956.9 ft. to a S 89\* 43 E along the south line of said NE± 956.9 ft. to a point on the centerline of the proposed runway extension to the Polson Airport, said point being the true point of beginning; thence from said true point of beginning N 89\* 43; W along said south line 426. ft. more or less to a point, said point being a perpendicular distance of 405.0 ft. from the centerline of said runway extension; thence N 18\* 30' E 100.0 ft. along a line larallel to said centerline; thence 71\* 30' E 70.0 ft. to a point; thence N 18\* 30' E along a line parallel to and at a perpendicular distance of 335.0 ft. from said centerline to the north line of the S½ of the NE½ 1315 ft. more or less: thence easterly along said north line to a point more or less; thence easterly along said north line to a point on a line parallel to and at a perpendicular distance of 275.0 ft. from said centerline 643. ft. more or less; thence S. 18\*
