A RESOLUTION PROPOSING TO EXTEND THE CORPORATE LIMITS OF THE CITY OF POLSON, MONTANA, SO AS TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED WHICH ARE CONTIGUOUS TO THE CITY OF POLSON, MONTANA.

WHEREAS, the City Council of the City of Polson, at a regular meeting held on December 4, 1967, at the City Hall in the City of Polson, Montana, duly considered the question of extending the boundaries of the City of Polson, to include the contiguous tracts of land hardinafter described and

of land hereinafter described, and

WHEREAS, it appearing to the City Council of the City of
Polson, Montana, that the following tracts of land are contiguous
to the City of Polson, Montana, to-wit:

Montana, forthwith notify in writing all property holders within the boundaries of the hereinbefore described tracts of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson, once a week for two (2) successive weeks, a notice of the passage of this resolution which notice shall further state that for a period of twenty (20) days after publication thereof, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson, Montana, as in this resolution provided, from freeholders of the territories herein proposed to be embraced in the corporate limits of the City of Polson, Montana.

RESOLUTION NO. 259.

A RESOLUTION CREATING AN EMERGENCY BUDGET FOR THE OIL NO. 14 FUND.
