ORDINANCE NO. 312.

AN ORDINANCE AMENDING SECTION 5-6-7 of THE CITY CODE OF POLSON, 1965, MAKING IT THE DUTY OF THE TREASURER TO COLLECT TRENSFER FEES AS WELL AS THE LICENSE FEES PROVIDED FOR IN SECTION 5-6-6 of THIS CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

SECTION 5-6-7 Of the City Codes of Polson, 1965, shall

be amended to read as follows;

Duty of Treasurer; The Treasurer shall be charged with
the collection of license and transfer fees herein provided for and application for license as well as application for transfer, accomanied by the fee therefore, sgall be submitted to the City Treasurer for filing by the City Clerk upon the approval by the City Council of the application for license or application for transfer as the

case may be.
The Treasurer shall prepare all blanks for application and transfer of the licenses provided for by this Section. and xxx shall keep all books of account in connection therewith, and axx and all expense in connection with the administration of this Chapter, shall, so far as possible, be charged against the funds collected under this Chapter.

REPEALING CLAUSE: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

EMERGENCY: An emergency is hereby declared to exist and this Ordinance is hereby declared to be necessary for the immediate preservation of public peace, health and safety, and therefore this Ordinance shall be in full force and effect from and after its passage and approval. RESOLUTION NO. 260.

WHEREAS, The City Council of the City of Polson, Montana, on the 4th, day of December, 1967, duly and regularly passed and adopted a Resolution declaring it to be to the best interest to the City of Polson, Montana, and of the inhabitants of the hereinafter described tracts of land that the boundaries of the said City be extended to include within the Corporate limits of the City of Polson, Montana, the said tracts of land, and

WHEREAS, it appears that no communications were in fact received within the said twenty (20) day period and the City Council, after due consideration deems it for the best interest of said City and the inhabitants thereof and the inhabitants of the hereinafter described contiguous tracts of land that the boundaries of the City of Polson, Montana, should be extended so ax to include the hereinafter described tracts of land withon the as to include the hereinafter described tracts of land withon the Corporate Limits thereof.

NOW, THEREFORE BE IT RESOLVED that the boundaries of the

City of Polson, Montana, shall be extended so as to include the property described as follows, to-wit:

Approximately Two (2) acres, more or less, of lot Six (6)

Section Four (4), Township Twenty-two (22) North, Range Twenty (20), M.P.M., More particularly described as follows:

Beginning at a point 140 feet west of Southwest corner of Lot Six (6), Section Xwantyx(20)x Four (4), Township Twenty-two (22)

North, Range Twenty (20), West, M.P.M.., thence west 132 feet; thence a due northerly direction 390.6 feet; thence North 69* a distance of 291.4 feet; thence in a due Southerly direction 395 feet, thence in a due westerly direction 140 feet; thence South 100 feet to the pount of beginning; and

Commencing at the Southeast corner of Lot six (6), in Section Four (4), Township Twenty-two (22), North, of Range Twenty (20), West, Montana Meridian; thence running West 140 feet; thence running North 100 feet; thence running East 140 feet; thence running South 100 feet to the point of beginning.

RESOLUTION NO. 261.

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA. TO CREATE A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, MONTANA, FOR THE PURPOSE OF BUILDING AND CONSTRUCTING A SANITARY SEWER SYSTEM IN SAID DISTRICT IN THE INTEREST OF THE HEALTH OF THE PROPERTY OWNERS THEREIN, AND THE INTEREST OF THE HEALTH OF THE FROFERIT OWNERS
THEREIN, AND THE INHABITANTS THEREIN, DESCRIBING THE BOUNDARIES
THEREOF, STATING THE GENERAL NATURE AND CHARACTER OF THE PROPOSED
IMPROVEMENTS, DESIGNATING THE NUMBER OF SAID DISTRICT, STATING
THE APPROXIMATE COST OF SAID IMPROVEMENTS, PROVIDING FOR THE
GIVING OF NOTICE OF THE TIME AND PLACE FOR THE HEARING OF PROTESTS AGAINST THE PROPOSED DISTRICT, THE WORK, ORV AGAINST THE CREATION OF SAID DISTRICT, OR THE EXTENT THEREOF, OR BOTH.
BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON,

LAKE, COUNTY, MONTANA;

SECTION 1. That the public health, convenience and safety requires, and it is deemed necessary to order, establish and create, and the City Council of the City of Polson, Montana, does hereby declare its intention to create a Special Dmprovement Sewer District within the City of Polson, Montana, the boundaries of which is hereinafter part-

icularly described.

SECTION 2. That this Special Improvement District shall be known ans designated as Special Improvement Sanutary Sewer District

Section 3. The boundaties os said Special Improvement District

is as follows, to-wit;
All of Lot Four (4) of Edevation Addition to the City of Polson, Montana, according to the official map or plat thereof, on file and of record in the office of the clerk and Recorder of Lake

County, Montana, and; A strip of land being twenty feet (20) in width, lying 10, on either side of the North South Center Linr of Block One (1) of Elevation Addition to the City of Polson, Montana, according to the official map or plat, on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

The above described District contains an area of approximately

96,000 square feet, kaginning being comprised of the areas hereinabove

particularly described.

All of said real estate included within the boundaries of said District aforesaid is the property benefitted by the creation of said District.

Section 4. That the District include within said boundary, and the area described therein is hereby declared to be the Disreict and the property benefitted by said improvement and the real estate and premises therein described, and therein included is hereby declared to be the property to be assessed for costs and expenses of making such improvements therein.

SECTION 5. The general nature and character of the proposed improvements to be made in said District is the building and construction of a sanitary sewer system to serve the property owners and

inhabitants thereof and th benifit the public health and safety.

SECTION 6. That the estimated cost, including all engineering fees, is approximately \$4,784.00, which sum is approximately \$187.00 per lot. layment thereof to be over a period of 20 years,
