RESOLUTION NO. 261.

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA. TO CREATE A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, MONTANA, FOR THE PURPOSE OF BUILDING AND CONSTRUCTING A SANITARY SEWER SYSTEM IN SAID DISTRICT IN THE INTEREST OF THE HEALTH OF THE PROPERTY OWNERS THEREIN, AND THE INHABITANTS THEREIN, DESCRIBING THE BOUNDARIES THEREOF, STATING THE GENERAL NATURE AND CHARACTER OF THE PROPOSED IMPROVEMENTS, DESIGNATING THE NUMBER OF SAID DISTRICT, STATING THE APPROXIMATE COST OF SAID IMPROVEMENTS, PROVIDING FOR THE GIVING OF NOTICE OF THE TIME AND PLSC E FOR THE HEARING OF PROTESTS AGAINST THE PROPOSED DISTRICT, THE WORK, ORV AGAINST THE CREATION OF SAID DISTRICT, OR THE EXTENT THEREOF, OR BOTH.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE, COUNTY, MONTANA;

SECTION 1. That the public health, convenience and safety requires, and it is deemed necessary to order, establish and create, and the City Council of the City of Polson, Montana, does hereby declare its intention to create a Special Dmprovement Sewer District within the City of Polson, ^Montana, the boundaries of which is hereinafter particularly described.

SECTION 2. That this Special Improvement District shall be known ans designated as Special Improvement Sanitary Sewer District Number 13.

Section 3. The boundaties os said Special Improvement District is as follows, to-wit;

All of Lot Four (4) of Elevation Addition to the City of Polson, Montana, according to the official map or plat thereof, on file and of record in the office of the clerk and Recorder of Lake County, Montana, and;

A strip of land being twenty feet (20') in width, lying 10' on either side of the North South Center Linr of Block One (1) of Elevation Addition to the City of Polson, Montana, according to the official map or plat, on file and of record in the office of the Clerk and Recorder of Lake County, Montana.

The above described District contains an area of approximately 96,000 square feet, ~~beginning~~ being comprised of the areas hereinabove particularly described.

All of said real estate included within the boundaries of said District aforesaid is the property benefitted by the creation of said District.

Section 4. That the District include within said boundary, and the area described therein is hereby declared to be the Disreict and the property benefitted by said improvement and the real estate and premises therein described, and therein included id hereby declared to be the property to be assessed for costs and expenses of making such improvements therein.

SECTION 5. The general nature and character of the proposed improvements to be made in said District is the building and construction of a sanitary sewer system to serve the property owners and inhabitants thereof and th benefit the public health and safety.

SECTION 6. That the estimated cost, including all engineering fees, is approximately \$4,784.00, which sum is approximately \$187.00 per lot. layment thereof to be over a period of 20 years,

SECTION 7. That upon the passage and approval of this resolution, the City Clerk of the City of Polson, Montana is hereby directed to give notice, by publishing and mailing, as provided by Section 11-2204

of the Revised Codes of Montana, 1947.

ORDINANCE NO. 313.

AN ORDINANCE AMENDING CHAPTER 7 of Title 11 of the City CODES OF POLSON, 1965, MAKING IT ILLEGAL TO USE, MAINTAIN, OR OPERATE TEEPEE BURNERS OR OTHER BURNERS FOR THE PURPOSE OF DISPOSING OF ANY WOOD, BARK, SAWDUST, OR OTHER TIMBER BYPRODUCTS OR OTHER INDUSTRIAL WASTES WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, AND REQUIRING ALL AUTHORIZED INDUSTRIES OPERATING WITHIN THE CITY LIMITS OF THE CITY OF POLSON, MONTANA, TO COMPLY WITH STATE AND FEDERAL AIR AND WATER POLLUTION STANDARDS, AND DECLARING IT AN EMERGENCY MEASURE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Sub-Chapter 2 of Chapter 7 of Title 11 of the City Code of Polson, 1965, shall be amended to read as follows:

USE REGULATIONS: Building and premises may be used for any purpose whatsoever; the following industrial operations as hereinafter defined shall be permitted within zone "D": Industrial, of the City of Polson zoning area:

1. The construction, maintenance and operation of wood products manufacturing plants.
2. The loading and unloading of unprocessed logs by railroad and trucks.
3. The storage of unprocessed logs and finished timber products and the movement thereof.
4. The processing of logs into manufactured products.
5. The construction, maintenance and operation of machinery and physical plant for such manufacturing purposes.
6. The construction, maintenance and operation of waste and by-product disposal facilities and processing equipment, including but not limited to storage bins, conveyors, debarkers, chippers, saws and related equipment together with needed utility installation for the use in connection therewith.
7. Provided further that the construction, maintenance and operation of any of the physical plants and equipment hereinbefore mentioned shall meet, comply with, and conform to the State of Montana and Federal Air and Water Pollution standards and otherwise be within limits which are common to the particular industry involved as to safety, noise and vibration. Provided, however, that nothing herein shall be construed to permit the construction, maintenance and operation of a wood pulp processing plant and the same is hereby specifically forbidden;

CHAPTER 7 of Title 11 of the City Code of Polson, 1965 shall be amended by the addition of Sub-Chapter 3 which shall read as follows:

It shall be illegal for any person, firm, or corporation to use, maintain or operate, or permit to be used, maintained or operated any teepee burners or other burners for the purpose of disposing of any wood, bark, sawdust, or other timber by-products or other industrial wastes within the city limits of the City of Polson, Montana: and provided further that each day that any person, firm or corporation shall operate any such burner in violation of this ordinance, shall constitute a separate offence and shall be punished accordingly.

Chapter 7 of Title 11 of the City Code of Polson, 1965 shall be amended by the addition of Sub-Chapter 4 which shall read as follows:

No Building or occupancy permit shall be issued for any of the following uses, and it shall, from and after the passage of this act, be unlawful for any person, firm or corporation to engage in any of the following prohibited industries within the City Limits of the City of Polson, Montana:

1. Wood Pulp or paper processing plant,
2. Acid Manufacture.
3. Distillation of bones, coal or wood.
4. Explosive Manufacture or Storage.
5. Fat Rendering.
6. Fertilizer Manufacture.
7. Garbage, Offal, or Dead Animal Reduction.
